Dear Candidate,

With reference to your application for advance admission to Ph.D. Programme at our Institute under the Quality Improvement Programme, I am glad to inform you that you have been selected for advance admission to this Programme in SJM School of Management for the Academic Session 2016-17.

As you are aware, this admission is under the scheme of 'Advance Admission for the Ph.D. Programme'. During the period between the offer of admission and the actual registration commencing in July, 2016, you are expected to visit this Institute, decide on your research area and problems, carry out literature survey and necessary design of your experimental work. This scheme envisages four visits amounting to a total duration of sixty days. (Please take prior approval of your Supervisor or Head of the Department to your visit every time).

1. You are advised to schedule your first visit as early as possible from 4th July, 2016 but in any case not later than 31st December, 2016.
2. For each visit you will be paid single 2nd class return rail fare by the shortest route from place of residence to this Institute and subsistence allowance as applicable to the participants of QIP - Advance Programme (at present Rs.100/- per day). This will be paid through this Institute.
3. The schedule of the subsequent visits and duration should be finalised during the first visit, in consultation with your Supervisor/Head of the Department. In any case 60 days must be completed latest by the end of April, 2017.
4. You are requested to submit sponsorship certificates to the CE & QIP Office when you come for the first visit. In case this is likely to be delayed, you should obtain a letter from Head of your Institution to that effect and submit the same to the CE & QIP Office at the time of your first visit. In addition, another certificate in the enclosed format signed by the Principal of your college should also be submitted.

We hope this scheme will help you to achieve a well planned Ph.D. research programme and thus enable timely completion of your research work and submission of the thesis within the period of deputation of three years.

Please note the following instructions and comply with them when you report to this Institute.

1. You will be issued identity card giving temporary student status. For this purpose you will have to submit one passport size photograph to the Academic Office.
2. Single accommodation for the periods of your visit may be provided in one of the Students' Hostels.

3. In case of sickness, you will be given medical facilities in our Institute hospital as per rules.
4. You will be given the library facilities for reading and referring books, journals etc. Books and journals will not be issued during visits.

Your admission and eligibility to join as full time QIP Scholar from the academic session commencing in July, 2017 will depend on the preparatory work done by you in the preceding year. Your admission will be confirmed after receipt of a detailed report signed by your prospective guide to the effect that you have carried out satisfactorily the preparatory work assigned to you.

The academic session 2016 - 17 will commence in the second week of 14th July, 2016. In case you accept this offer of admission you will have to pay the prescribed fees and deposits (details of which will be communicated in due course).

On arrival at this Institute for your first visit, you may report to the Hostel Coordinating Unit (Basement, Main Building Annex) for your accommodation and to the CE & QIP Office (17th Floor, Main Building) for further instructions. Please note that the accommodation in the student hostel is subject to availability. It may help you to first check for availability before planning your visit.


