MEMORANDUM OF UNDERSTANDING

The Parties to the present MOU having considered that they have common aims and interests in the field of teaching and research. The institutions wish to enhance academic cooperation in the framework of the higher education on international platform and to expand educational opportunities. Thus S.M.B.T. College of Pharmacy, Nashik, (M.S.) and SLT Institute of Pharmaceutical Sciences, Bilaspur (C.G.)

Have Agreed

To sign a Memorandum of Understanding (MOU), details as follows-The MOU is designed to facilitate and develop a genuine and mutually beneficial exchange and collaboration. Both parties hereby agree to encourage exchange and collaboration, as appropriate between their departments, research institutions and staffs. In this joint program, both parties will be guided by their mutual interest in promoting development of scholarly and cultural cooperation between their respective institutions.

S.M.B.T. College of Pharmacy, Nashik, (M.S.) and SLT Institute of Pharmaceutical Sciences, Bilaspur (C.G.) counterparts shall encourage contact and the exchange of information between members of their staff to facilitate the development of following:

- 1. Visits by and exchange of staff for academic research;
- 2. The development of joint research and innovation activities;
- 3. Visit by and exchange of students for study and research;
- 4. Organization of Joint events: Conference, Research project, Workshops and Symposia, etc;
- 5. Laboratory Facilities, assignments, Projects, and administration;
- 6. Practical Training and programmes of integrated knowledge;
- 7. Short courses and special short term academic programs;
- 8. Other activities and programs as mutually agreed upon by both institutions.

As specific academic exchanges and collaborative activities are identified and agreed to by the two institutions, the term of mutual assistance and necessary budget for each program and the activity that is implemented and other specific details of these activities shall be mutually discussed and agreed upon, in writing, by both parties, prior to the intimation of the particular program or activity. Such programs and activities shall be negotiated in a timely manner. Both parties understand that all financial arrangements will have to be separately negotiated and will depend on availability of resources. Any exchange of students and faculty members must be approved by the host institution in advance. Transfer of coursework credit must be secured in advance by the student at his/her home institutions.

This MOU shall remain in force for a period of three (03) years from the date of the last signature, with the understanding that it may be terminated by informing the other through written notice six month in advance. In the event of termination, the provisions of this agreement shall continue to apply to on-going programs until their completion. This MOU may be amended by the exchange of letters between the two institutions. Any amendments or notification require written approval by authorized signatories of each institution and shall be appended. Such amendment once approved by both institutions, will be part of this MOU.

The Parties, by the signature of their authorized representatives, acknowledge having read and understood this MOU and agree to be bound by its terms and conditions.

The MOU has been executed by the legally authorized representatives of the said parties, two identical copies, all in English, of which the parties have taken one each.
