Sub: Offer of appointment to the post of Assistant Professor (Mathematics) in the Applied Mathematics and Humanities Department.

Sir,

With reference to your application and subsequent interview, the competent authority have pleasure in offering you the post of **Assistant Professor (Mathematics) in the Applied Mathematics and Humanities Department** (in the pre-revised scale of Pay in Pay Band of Rs.15600-39100 with AGP-8000) with the pay at **Rs.101500/- p.m.** in the Cell No. 1 of Pay Level 12 of the revised scale as per the 7th CPC plus allowances as admissible as per rules of this institute from time to time, subject to the following terms and conditions:-

- (1) The post is permanent but you will be on probation for a period of one year from the date of joining after which period you will, if confirmed, hold office, subject to the provisions of the institute/MHRD rules and regulations as applicable till the end of the month in which you attain the age of 65 years. The appointing authority reserves the right to extend the period of probation, if necessary.
- (2) In case you wish to leave the said post during the probation period you shall give one month's notice to the institute or pay one month's salary in lieu thereof. On your satisfactory completion of probation you will be confirmed in the post of which separate orders will be issued. After confirmation your services can be terminated by giving three months notice or on payment of three month's salary in lieu thereof, on either side. The Institute may accept salary for a period by which the notice falls short of three months.
- (3) If at any time it comes to the notice of the Institute that you have made any false statement in your application or submitted any false document therewith or suppressed or concealed from the institute any information which would disqualify you for appointment, your services are liable to be terminated without giving any notice whatsoever and in addition the Institute reserves the right to take such further action against you as it deems fit.
- (4) That, you will not engage in any trade or business or undertake any employment full time or part time, failing which, disciplinary action will be initiated.
- (5) That, you will be governed by the present service rules, regulations and decisions of the Institute as may be amended from time to time.
- (6) **If this offer of appointment is acceptable to you, please return one copy of this letter duly signed in token of such acceptance and report for duty to the undersigned on or before 11/02/2019 through the Head of Applied Mathematics and Humanities Department, SVNIT, Surat.** In case you do not join duty by the stipulated date, this offer will be treated as cancelled for which no separate communication will be sent to you.
