

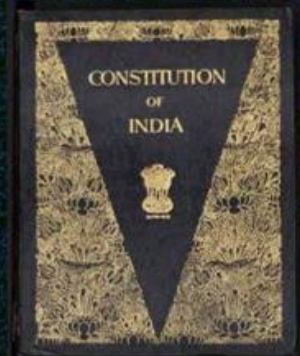

Code of Conduct for Students

The students are admitted to Guru Ghasidas Vishwavidalaya to achieve excellence and shape their character to become responsible citizens. They must realize their responsibility towards the Vishwavidalaya and to its components like faculty, staff and fellow students. Failure to maintain a good standard of conduct shall result in disciplinary action.

Attendance: 75% attendance is compulsory in each subject

Misconduct:

Any of the following activities (but not limited to these only) will be treated as misconduct.

- Disruption of teaching activities or disturbing the learning process of other students on the campus.
- Any act on the part of the students, which disrupts functioning of the university, endangers health and safety of campus residents and damages Vishwavidalaya properties.
- Cheating in examination and supplying of false documents / information in order to seek any consideration / favour from the University.
- Possession or consumption of intoxicating beverages on the campus.
- Failure to return back loaned material, settle University dues.
- Possession of weapons.

Disciplinary Actions: Failure to adhere to good conduct may result in disciplinary actions like:

- A warning by the authorities.
- Suspension from a particular class.
- Suspension / expulsion from the University.
- Suspension of campus privileges e.g. hostel, accommodation etc.
- Withholding of examination result or withdrawal of awarded diploma / degree certificate.
- Any other disciplinary action deemed appropriate by the University authorities.

Anti Ragging Rule

What Constitutes Ragging

Ragging constitutes one or more of any of the following acts:

- Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student;
- Indulging in rowdy or indiscipline activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student.
- Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating sense of shame, or torment of embarrassment so as to adversely affect the physique or psyche or such fresher or any other student;
- Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher;
- Exploiting the services of a fresher or any other student for completing the academic tasks assigned to any individual or a group of students;
- Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students;
- Any act of physical abuse including all variants of its; sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person.
- Any act or abuse by spoken words, email, post, public insults, which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student;
- Any act that affects the mental health and self-confidence of a fresher or any other student, with or without an intent to derive a sadistic pleasure of showing off power, authority or superiority by a student over any fresher or any other student.

Important Points

- Fresher (s) and all other student(s) should desist from doing anything, with or against their will, even if ordered to by the senior students.
- Fresher (s) or any other student (s), whether being victims, or witnesses, in any incident of ragging are advised to promptly report such occurrence at the Anti-Ragging Helpline. Apart from the helpline number the students are free to contact any of the University Officials.
- The University will ensure that the identity of such informants shall be protected and shall not be subject to any adverse consequence only for the reason for having reported such incidents.
Punishment(s) in the event of Ragging

One or more of the following punishments depending on the nature and the gravity of the guilt may be awarded to those found guilty namely:

- Suspension from attending classes and academic privileges.
- Withholding /withdrawing scholarship/fellowship and other benefits.
- Debarring from appearing in any test/examination or other evaluation process.
- Withholding results.
- Debarring from representing the University/Institution in any regional, national or international meet, tournament, youth festival etc.
- Suspension/Expulsion from the hostel.
- Cancellation of admission.
- Rustication from the University/Institution for period ragging from one to four semesters.
- Expulsion from the University/Institution and consequent debarring from admission to any other institution for a specified period.

Provided that where the persons committing or abetting the act of ragging are not identified, the University shall resort to collective punishment.

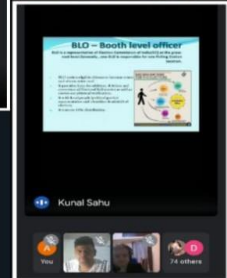
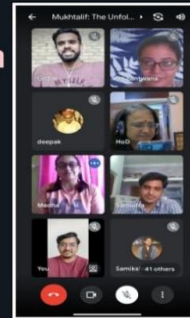

Facilities for the students

Campus

- The greenest, bio - aesthetic exquisite campus enriched with clean and fresh environment spreads over an area of 655 acres.
- Along with the scholarly ambience, the campus also comprises of extra- academic facilities needed for the enhancement of all-round development of the students.

Library

Nucleus of Academics our Well-Stocked Library located in main campus caters the needs and exigencies of the students, teachers and Research scholars.

The cavernous building can accommodate more than 500 people at a time and inventory of 128000 books, 400 back volumes of journals, 1500 Ph.D. thesis.

An internet and Wi-Fi service is also free of cost.

UGC Info net and INDEST consortia services are also made available.

Computer Centre

The University has modernized computer centre with several versions of Linux and Windows operating systems to compliment computer literacy.

A large number of peripherals such as printers, LCD projectors, scanners and other multimedia devices are handy for users.

The internet connection is provided to all.

It also maintains University website www.ggu.ac.in (250 web pages) which provides all the relevant information and notifications regarding the university's happenings.

Women's Studies Development Centre

Women's Studies development centre is the first centre of Women's Studies development in the state and was entrenched in 2005.

The centre concentrates on the raising consciousness and knowledge of gender equality and equity issues through participatory activities

Training and Placement Cell

It's backed by School placement cells which aim to act as an association between industry and the university.

The cell takes care of all the activities to make the students employable and self-reliable.

Recently, many companies/Industries having International dignity like TCS, Sake Solutions Wipro BPO Satyam Services Private Limited have recruited are bright scholars.

Proctorial Board

The university has constituted a Proctorial Board for keeping its campus well disciplined.

The Board takes prompt action in case of any misconduct if occurs in the campus and recommends appropriate punishment for students found guilty.

It also takes all the preventive measures against ragging and examines the cases of alleged ragging (if any).

All the students are required to submit an undertaking to the proctorial board as not to be involved in any type of misconduct at the time of admission.

Hostel Facilities

Four hostels, three for boys and one for girls separately, provide accommodation to 800 approx boys and 430 girls.

Two more girls Hostels of capacity 200 will be available very soon for allotment. Vishwavidyalaya faculty member as Warden supervises each hostel.

The university aims to provide a comfortable lodging and boarding services to the students keeping in view a home away from the home.

Admission in hostels is based on merit as per university rules and the students will be required to apply in the prescribed application form.

In view of the limited hostel facilities available, the candidates may please note that the grant of admission to a course of a study in the UTD would not automatically entitle one for allotment of hostel accommodation and that the application of the students for Hostel allotment will be considered if seats in the hostel are available.

Hostel residents are expected to observe the rules and regulations prescribed for them as well as all the requirements of corporate life and the social norms that living together demands.

Failure to observe discipline or violation of rules may make a student liable to disciplinary action which may result in the withdrawal of Hostel Facilities.

Cafeteria

New Cafeteria Building with G+1 floor was constructed with grant-in-aid from UGC XI plan. It is situated behind university auditorium. It has one big cafe-seating hall of 25m x 16m at ground floor. The Cafeteria is successfully catering to the daily needs of the university community. The Cafeteria remains open on all working days from 8.00 a.m. to 7.00 p.m.

Health Centre

Health facilities are available for students and residents of the campus under the able guidance of a Medical Officer and other visiting specialist, as per needs. Specialist from CIMS also visit the health center in the campus from time to time for specialized checkup & advice.

Student Creativity Centre

University has developed Student Creativity Centre in which various types of facilities including indoor games such as table tennis, Chess etc are available. Entertainment facilities and leisure time reading magazines are kept for the personality development of the students during their off time. The centre is run and maintained by the constituted student council under the supervision of Dean, Students welfare.

Tarang- The University Musical Band

It is the university's musical band which is a student managed group. Every year, 09 students is recruited in the group.

Udaan-The Official Student Magazine

The Official annual magazine of the university "Udaan" is made and managed by the students. It gives a platform to the creative minds of the university as well as contributes to the overall development of its members. It helps them to grow skills and enhance their creativity

Urchins-University's Theatre and Nukkad Play Group

“Urchins” is the theatre and nukkad play group of this university, which is well-known in entire Chhattisgarh. It presents its programs on state level and is also engaged in the effort to advance the level of theatre.

Abhitartan- University's Dance Group

It is a special platform to provide the opportunity to the students having interest in dancing. In the six year of its journey the group has proved itself on intra and inter-university level competitions and presentations, full of classical and semi classical and folk dance specials.

Auditorium

The campus has fully developed Auditorium with a seating capacity of about 800 audiences.

Gymnasium

Well-equipped and ultra modern gymnasium has been established in the campus for students.

Sports Centre

The University has fully furnished Sports Centre to promote athletic expertise of youth.

Post Office and Bank

Punjab National Bank, Bank of India and Post Office Koni are rendering their services in the campus. ATM facilities by PNB is available in the campus. A new electronic telephone exchange is also established in the campus.

Psychological Counselling Centre

As per guidelines of the MHRD, Govt. of India and State Govt. of Chhattisgarh, State Mental Health Hospital, Sendri, Bilaspur under the National Mental Health programme, the university has established the Psychological Counselling Centre on 29th November 2016.

SC/ST Cell

As per UGC guidelines, the university possesses a separate SC/ST cell which processes and provides assistance to the SC/ST students.

National Service Scheme (NSS), National Cadet Corp (NCC)

The NSS/NCC targets to inculcate the spirit and provide working experience for social services through various team-building activities.

Grievance Redressal Mechanism

The University has its own Grievance Redressal Mechanism. The University has constituted many committees which are redressing the grievances received from students and employees. To redress grievances related to sexual harassment, the University has constituted Internal Complaint Committee (ICC). Similarly for redressal of grievances related to students, the University has constituted Grievance Redressal Committees also. The University Administration has provided Complaint Box in its campus to the students and employees. Students or employees can drop their complaints or feedbacks in these boxes.
