Item No. 1: Regarding reconsideration on appeal of Shri Santosh Yadav (superintendent, terminated) on directions of Hon'ble High Court of Chhattisgarh in WP(S) 6254/2014 vide order dated 06.03.2017.

The Executive Council considered the appeal of Shri Santosh Yadav in the light of the order passed by the Hon'ble High Court of Chhattisgarh on 06/03/2017 in the petition No. WP(S) 6254 of 2014 wherein Para 8 of the said order it is mentioned, "**The matter is remitted back to the Appellate Authority to take a fresh decision on the appeal of the petitioner**" and in light of the subsequent contempt petition filed by Shri Santosh Yadav vide No. CONT 480/2017, the appeal, as per the direction of the court was considered afresh in the absence of Dr. M.S.K. Khokhar and Dr. I.D. Tiwari.

The appeal, all facts and report of the committee, other documents and evidences as the CD were physically examined and viewed by the members during the EC meeting. It was pertinently observed that the two files in the CD are recorded on 08-06-2010 and 08-07-2010, respectively, as reflected while the media file was being played.

Resolved that, on the basis of the review of all the facts, documents and CD related to the matter, the members of the committee felt that the termination of the services of Shri Santosh Yadav Vide office order No 05/Prasha/Stha/U.Ku./2013 dtaed 10.06.2013 dated 10-06-2013 deserves modification. Hence, the said order No05/Prasha/Stha/U.Ku./2013 dtaed 10.06.2013 be modified and services of Shri Santosh Yadav be treated as having being compulsory retired from the date of termination i.e. 10-06-2013 with full gratuity and pension benefits be decided as per the provisions of CCS Pension Rules 1972.


