2. **Merit list of candidates will be decided on the basis of marks scored in CUET PG 2022 Examination. However, in case of any tie in CUET Marks, higher percentage of UG class shall be considered for merit, in case of further tie higher percentage of class 12th, and then 10th class shall be considered for merit. And if in case of further tie elder students shall be considered in merit.**
