6. Migration Certificate

9. Valid category Certificate [SC/ST/OBC (Non Creamy Layer)/EWS/PH, etc.], if applicable.
Latest income certificate for OBC in case the OBC certificate is issued on or before 01.07.2021.
10. Gap Certificate, if applicable
11. Aadhar Card
12. 5 set of Coloured Photograph with white background

If after physical verification any candidate is found eligible for admission, he/she will have to pay the admission fee. Only then his/her admission will be confirmed. Students are suggested to bring with them Mobile and Debit/Credit Card having sufficient balance for submission of fee. Non Payment of fee within due will be treated as cancellation of admission and the seat so vacated will be filled up student in waiting list.

Copy of the fee receipts along with the original Transfer Certificate/School Leaving Certificate, Character Certificate, Income Certificate, and Migration Certificate requires to be submitted in the department to complete the admission process.

If hostel accommodation is required, student can give application for the same on plain paper with CUET score Card (LLM), two photographs, and one set of all documents as above mentioned.

Admission will be granted on the basis of the marks scored in CUET PG 2022 Examination. Mere appearance in offline counseling does not entitle an applicant for confirmed admission unless he/she is in merit list. If any student does not appear for physical verification with above mentioned documents, he/her candidature will not be considered for admission.
