Minutes of the 26th Meeting of the Executive Council Held on 01.10.2019

The meeting started with the opening remarks of the Vice Chancellor/Chairperson and the agenda were taken item wise.

The Executive Council also noted and discussed the comments received from MHRD on the Agenda Items of this 26th Executive Council Meeting while considering each Agenda Item in the meeting.

Item No. 1 To confirm the minutes of the Executive Council meeting held on 09-08-2019.

Resolved that the minutes of the meeting of the Executive Council dated 09-08-2019 be confirmed.

Item No. 2 Reporting of compliance and progress report on the decision taken by the Executive Council at its meeting held on 09-08-2019.

The Executive Council perused and noted the compliance and progress report on the decisions taken by the Executive Council in its meeting held on 09.08.2019.

Item No. 3 To approve the minutes of the Standing Committee of Academic Council meeting held on 25-07-2019, 08-08-2019, 19-08-2019, 23-08-2019 and 11-09-2019.

Resolved that the minutes of the Standing Committee of Academic Council meetings held on 25-07-2019, 08-08-2019, 19-08-2019, 23-08-2019 and 11-09-2019 be approved.

Item No. 4 To ratify the advertisement No. 110/Rec/Adm/19 Dated 11-06-2019 regarding appointment of Guest Faculty in Department of Law on purely temporary basis.

Resolved that the advertisement "No. 110/Rec/Adm/19 Dated 11-06-2019" in the subject of this Agenda Item be read as "No. 769/Rec/Adm/19 Dated 14-09-2019".

Resolved Further that the advertisement vide No. 769/Rec/Adm/19 Dated 14-09-2019 regarding appointment of Guest Faculty in Department of Law on purely temporary basis be ratified.

Item No. 5 To ratify the advertisement No. 494/Rec/Adm/19 Dated 13.08.2019 floated for appointment of Statutory positions of Registrar, Finance Officer and Controller of Examination.

Resolved that the advertisement No. 494/Rec/Adm/19 Dated 13.08.2019 published for appointment of statutory positions of Registrar and Finance Officer only be ratified.

Resolved Further that a letter be sent to the UGC, New Delhi for the sanction of one position of Controller of Examinations. Till then the process of appointment to the post of Controller of Examinations be deferred and a notification be issued to this effect.

Item No. 6 Regarding nomination of members in the selection committees of Registrar, Finance Officer and Controller of Examinations.

The Executive Council perused and discussed the comments of the MHRD as well as the provision of Section 44 (b) of Central Universities Act 2009 regarding nomination of members in the selection committees for appointment of first Registrar and first Finance Officer in the University. The Executive Council also

noted that the posts of Registrar and Finance Officer have been advertised vide Advertisement No. 494/Rec/Adm/19 dated 13.08.2019 in accordance with UGC/MHRD, GoI norms. The Executive Council further noted that the MHRD in its comments on Agenda Item No. 06 has informed that, it was decided with the approval of the President in capacity as the Visitor of Central Universities, to advertise these posts, through the University, and to select suitable persons, through a Selection Committee consisting of the Vice – Chancellor as Chairman and two other members co-opted by the Vice-Chancellor out of a panel of names approved by the Visitor. It was also decided that the Selection Committee shall recommend a panel of not less than three names, drawn in alphabetical order for consideration of the Visitor. In view of this,

Resolved that the Selection Committee for appointment of first Registrar and first Finance Officer shall consist of Vice-Chancellor as the Chairman and two other members co-opted by the Vice-Chancellor out of a panel of five Visitor's nominees provided to the University for Selection Committees.

Resolved Further that the meeting of the Selection Committee for appointment of first Registrar and first Finance Officer be convened wherein the Selection Committee shall recommend a panel of not less than three names, drawn in alphabetical order for consideration of the Visitor.

The Executive Council also perused and discussed the provision of Sections 8 & 18 of Statutes of the Central Universities Act 2009 regarding nomination of members in the Selection Committee for appointment of Controller of Examinations. The Executive Council further noted that a total of three members of Selection Committee for Controller of Examinations are to be nominated by the Executive Council in the following manner: (i) Two members of the Executive Council nominated by it and (ii) One person not in the service of the University nominated by the Executive Council. The Executive Council after deliberation and discussion,

Resolved that for Selection Committee of Controller of Examinations, the Chairperson of the Executive Council be authorised to nominate two members of the Executive Council and one member not in the service of the University, on behalf of the Executive Council.

Item No. 7 Consideration of revision in Roster of various Teaching positions and Corrigendum made in the vacancy positions in the Advt No. 105/Rec/Adm/2019 dated 03.06.2019.

Resolved that the revised Roster as per recommendation of the Roster Committee in its meeting on 23-08-2019 as approved by Standing Committee of the

Academic Council in its meeting on 23-08-2019 and the amendments in the vacancy positions made in the above advertisement dated 03-06-2019, vide corrigendum No. 511/Rec/Adm/2019 dated 23.08.2019, be ratified.

Item No. 8 Regarding consideration of the matter of not reporting to University after the study leave by Shri Deepak Rathore, Assistant Professor, Department of Electronics & Communication Engineering.

The Executive Council discussed and deliberated in the matter of Shri Deepak Rathore with reference to the relevant documents & facts as well as Writ Petition (WPS) No. 6421/2018 for payment of emoluments/salary during the period of Study leave.

Executive Council perused the reply of the University submitted to MHRD, GoI vide GGV letter No. 2478/Est/Adm/2019 dated 28/08/2019 as well as letter of Hon'ble Minister of State, MHRD, Communication and Electronics & Information Technology, GoI, Shri Sanjay Dhotre vide अ.शा.पत्र.सं. 49-5/2019-CU-I dated 11.09.2019 addressed to Hon'ble Minister of Agriculture & Family Welfare, Rural Development & Panchayati Raj, Shri Narendra Singh Tomar in the matter of Shri Deepak Rathore.

Resolved that the payment of salary/emoluments to Shri Deepak Rathore during the study leave period, which has already been initiated, be processed as per rules.

The Executive Council noted that Shri Deepak Rathore applied for extension of the study leave vide his application dated 01.07.2019 forwarded by his Supervisor. The University vide its letter No. 2395/Est/Adm/2019, Bilaspur dated 14-08-2019 informed Shri Deepak Rathore that his study leave was not extended by the University. Shri Deepak Rathore has filed Writ Petition (Service), of 2019, before the Hon'ble High Court of Chhattisgarh to quash the above University order.

Resolved Further that as the matter of extension of his Study Leave is subjudice, necessary action in this regard be taken after the decision of the Hon'ble High Court.

Item No. 9 Regarding consideration of the matter related to absence of Mrs. Bhawana Shukla, Assistant Professor, Department of Electronics & Communication from the duty.

The Executive Council discussed and deliberated in the matter of Mrs. Bhawana Shukla with reference to the relevant documents and facts. The Executive Council also noted that Mrs. Bhawana Shukla has joined her duty w.e.f 16.09.2019 and



submitted medical certificates for a period from 01.07.2019 to 14.09.2019. The Executive Council also took a serious note on her act of repetition for being continuously absent from the duty without sanction of leave from the Competent Authority of the University. After deliberation and discussion on the matter,

Resolved that the whole matter regarding act of repeated and long absence of Mrs. Bhawana Shukla from the duty without sanction of leave by Competent Authority be examined in totality by a Committee and the report/recommendation of the Committee be placed in next meeting of the Executive Council.

Resolved Further that the Chairperson of the Executive Council be authorised to constitute the Committee.

Item No.10. Considering minutes of meeting of Committee and Legal Opinion on the matter of constitution of DPC and promotion of Non-Teaching Staff.

The Executive Council perused and discussed the recommendation of the Committee (constituted vide OM No. 2115/Estt/Adm/2019 dated 18-07-2019 and revised OM No. 2239/Estt/Adm/2019 dated 01.08.2019) in its meeting held on 08-08-2019 as well as the legal opinion obtained on the matter of constitution of DPC and promotion of Non-Teaching Staff.

Resolved that the recommendations of the Committee in its meeting held on 08-08-2019 be approved.

Item No. 11 To consider the recommendations of the Selection Committee meetings held on different dates.

Sealed envelopes containing recommendations of the selection committee meetings held between 11-09-19 to 30-09-19 for the Departments of Forensic Science, Chemistry, Zoology and Commerce, were placed before the Executive Council.

Executive Council took note of the interim order passed by the Hon'ble High Court of Chhattisgarh, Bilaspur in WP(s) No. 7443 of 2019, Smt Sushma Upadhyay Vs. Guru Ghasidas Central Universities & Ors., relevant portion of which reads as follows –

"However, the results of the interview of the petitioner as well as the results of the interview of the respondents No. 3 & 4 shall not be published and declared without the leave of the Court till the next date of hearing."

Resolved that in view of the directions of the Hon'ble high Court of Chhattisgarh mentioned above, and also the fact that the petitioner Smt Sushma Upadhyay and respondents Nos. 03 & 04 i.e., Dr. I Arjun Rao and Dr. Moumita Sinha respectively, are applicants under unreserved

Resolved Further that since respondent No. 03 Dr. I.
