## Important instructions to Applicants

- 1. All qualified candidates of VRET Exempted category 2022-23 only are eligible for appearing at the stipulated date and time.
- 2. All applicants seeking admission for PhD programme shall present their research proposal only in advertised areas of specialization.
- 3. Time limit for the presentation is 8 minutes and 2 minutes for discussion.
- 4. Applicants ,who have not yet submitted NOC (No Objection Certificate) ,Experience certificate, caste certificates, income certificates etc for availing the benefit of reservation are required to submit the documents before the meeting of the DRC. An applicant who fails to submit the required documents before the DRC meeting (i.e. 12th May,2023) for availing the benefits of reservation, shall be treated under unreserved category subject to eligibility.
- 5. Provisional admission will be given to the selected candidates after the interview on schedule date. Admission will be confirmed by the Department only after physical verification of documents during Pre-Ph.D Course Work. Mere appearance in the entrance test/ interview or securing a place in merit/ selection list at the time of provisional admission does not entitle an applicant to be considered for confirmed admission to any discipline unless otherwise he/she fulfills the eligibility conditions with necessary supporting documents.
