**If there are no addition, alteration, deletion and modification in the voter list, the concerned Head of the department should send (proforma 2A) duly filled in, through the respective Deans to office of the undersigned by 12.00 hours on 22<sup>nd</sup> February, 2019.**

Furthermore, a meeting of all Deans of Schools and Heads of the Departments will be held on **26<sup>th</sup> February, 2019 at 14.00 Hours** in the **Smart Class Room of Department of Biotechnology** to discuss the issues related to election. Kindly ensure the presence of all concerned.
