The bidder is therefore advised to see the area and ascertain requirements before submitting the bid.
22. The material should be delivered and installed at GGV Campus, Koni, Bilaspur (C.G.) Transportation, Installation, and any other charges, if any, will be borne by the supplier.
23. Sub-letting of the Contract: The successful applicants shall be responsible for full execution of the contract and shall not in any case assign or sublet ordered items or part thereof to any other party. Failure to do so will attract cancellation of the order.
24. The work shall have to be started within **three** days from the date of issue of work order/contract. In case, if the work is not started within above period, the earnest money shall be forfeited.
25. During the execution of the works, the University may desire to provide or install any other relevant items which are not listed in the scope of the work. In such case the firm shall have to carry out the addition works at the prevailing market rate.
