Office Memorandum

An emergent meeting of Standing Committee of Academic Council was held on 13.03.2020, 10.00AM in the Conference Hall of Administrative Building. To help in preventing/reducing the transmission of Novel Coronavirus (COVID-19) the committee resolved following in the light of the directions and advisories of the UGC, Government of India and Chhattisgarh State Government. And therefore, following is hereby notified for information to all –

1. All meetings (including BoS, DRC, Selection Committees etc.), all gatherings, seminars, conferences, group activities, all functions of Guru Ghasidas Vishwavidyalaya be cancelled till 31.03.2020. For all such deadlines for any academic activities (including BoS, DRC etc.), a grace period of 15 days i.e. upto 15.04.2020 shall be given.
2. All classes shall be suspended till 31.03.2020. The University shall review the situation in due course of time and will inform the students about schedule of classes, internal tests and examinations.
3. Hostels of the University be vacated by tomorrow evening 06.00 PM. Mess of the Hostels be closed from 15.03.2020. Students shall be eligible for mess cut as per hostel rules. The University shall provide railway concession and local conveyance to the students of hostels upto Bilaspur Railway Station.
4. All departments and offices shall remain opened and teachers of the departments shall remain in contact with the concerned students and will provide study material online (through Email) to the students, if required.
5. Cafeteria and Central Library will be closed till 31.03.2020.
6. Admission Brochure and Admission Notice for VET 2020-21 shall be drafted by the Academic Section and be circulated through Email. All members of Standing Committee of Academic Council will send their opinion through Email, if any correction is required. The Admission Notice- 2020-21 shall be finalized and be approved by the SC of AC by circulation.
7. All the stakeholders of the University shall maintain the advisories issued by the University vide OM NO. 787/Estt/Admn/2020 Dated 12.03.2020 and UGC DO No. 1-14/2020 (Website) Dated 05.03.2020.


