5. A self-attested copy of Ph.D. Registration Certificate

6. A copy of Caste / Disability Certificate in case of SC/ST and Persons with Disability, duly self-attested.

After receipt and acceptance of these documents by ICSSR, a formal Sanction Order for the award of the Doctoral Fellowship will be issued and subsequently the Fellowship Grant shall be transferred through PFMS to the concerned Registrar/Director/Principal of the University/Institute/College along with a copy of the sanction marked to you. Kindly note that the fellowship grant shall be sanctioned only after a careful scrutiny of the documents submitted along-with the hard copy of the application which should be properly forwarded. Please make sure that your topic of research is essentially the one approved by the relevant body of authority where you are affiliated and with that you had applied for the ICSSR Doctoral fellowship. In this regard, the affiliating university must ensure that their bank account for receipt of the ICSSR Grant (Scheme Code 0877) is already linked to PFMS portal to enable release of grant otherwise it shall not be possible to release the fellowship grant as per the GOI notification. The list of institutions whose bank account are already linked to PFMS may be seen on ICSSR website, others may contact the undersigned.

In case, the awardee does not join within 15 days from the date of issue of this letter, the application shall be treated as withdrawn. In case the scholar has any difficulty in joining or does not intend to avail ICSSR Fellowship, then the awardee/the affiliating University should mandatorily inform ICSSR in written, within a fortnight.


