1. Your basic pay will be Rs. 13,680/- (*Rupees Thirteen Thousand Six Hundred Eighty Only*) per month in the pay scale of Rs. 12000-420-18300 plus allowances as per University rules. Gross Salary at the Basic Pay of Rs. 13,680/- will be Rs. 47,436/-per month. In addition, you shall also be given a Special Allowance of Rs. 62,564/-per month. 5. You will be expected to do teaching and research work and such other work as may be assigned to you from time to time.
6. During the period of your employment with the University, you will not engage, show concern, interest directly or indirectly in any other occupation, business or employment whatsoever without the prior consent in writing of the University and you shall devote your time, attention and abilities exclusively in performance of your duties. You shall, in all respects, obey and conform to the University's orders and regulations and will faithfully serve the University and put your best endeavor to promote the interest of the University.



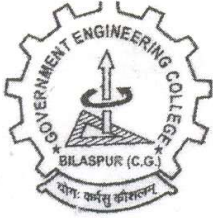


