MEMORANDUM OF UNDERSTANDING
BETWEEN
GURU GHASIDAS VISHWAVIDYALAYA, BILASPUR (C.G.)
And
SAURASHTRA UNIVERSITY, RAJKOT, GUJARAT
FOR "EK BHARAT SHRESHTHA BHARAT" SCHEME



THE MEMORANDUM OF UNDERSTANDING (MOU) IS ENTERED ON..... BETWEEN GURU GHASIDAS VISHWAVIDYALAYA, BILASPUR (C.G.) And SAURASHTRA UNIVERSITY, RAJKOT.

Both the paired parties with complementary task have come to the understanding to promote co-operation between the two organizations in the field of cultural activities, extracurricular activities, Sarva Shiksha Abhiyan, sports, education, research, development as well as other activities under the Ek Bharat Shreshtha Bharat scheme as per guidelines given by the MHRD time to time, which will be inherent part of MoU. Both the parties agree to the following broad terms of cooperation:

- 1) **Exchange of cultural activities:** both paired universities exchange will the cultural activities such as drama, song, elocution, and skits etc. in a cultural festival / cultural week on exchange basis to be performed before the audience of the other states.
- 2) **Exchange of extracurricular activities:** The extra-curricular activities like adventure camp, cycling, motorcycling, historical tours etc. be organized by the two universities of the paired states. The students of both the universities participate in the above said activities.
- 3) **Academic exchange:** The teachers/ resource persons/ academicians will share their thoughts with paired universities in the form of lectures/seminars/ conference/ workshop etc. in general and special attention will be given to the key subjects of history, language and social sciences.
- 4) **Sarva Shiksha Abhiyan:** Under the Serv Shiksha Abhiyan special lectures/ activities will be organized between paired states on the occasion of festivals/ leaders birth anniversary etc. of the other states during the pairing year.
- 5) **Skilled Development:** The different programs/ activities which are organized under the banner of MHRD/Govt. of India/UGC may be exchanged between the two paired states from time to time or as and when required.
- 6) **Sports:** The different sports activities be organized with mutual understanding of the paired universities.
- 7) This MoU also serve purpose of Rashtriya Avishkar Abhiyan and Unnat Bharat Abhiyan of MHRD through inspiring and motivating the young minds, teachers and students for research as well as innovation.

TERMS AND CONDITIONS:

- 1) **Financial Provision:** To conduct above activities the financial liabilities will be shared on the following basis: -
 - a. The travelling expenses, food allowances as well as medical (if any) expenses of the students/spot person (other than faculty) during the journey that is from parent University to the host university will be given by parent University as per their financial norms.
 - b. Travelling, hospitality as well as medical expenses (if any) of the students/sports person (other than faculty) will be provided by host institution after the arrival at the host university during the activities or programme.
 - c. The travelling expenses and food allowances of the faculties/employee will be given by parent University as per their financial norms.
 - d. Hospitality of faculty and employee will be provided by host University during the entire programme.
 - e. The travelling expenses, food allowances as well as medical (if any) expenses of the Artists/Resource person (other than faculty) during the journey that is from parent university to the host university will be given by parent university as per their financial norms.
 - f. Travelling, hospitality as well as medical expenses (if any) of the Artists/Resource person (other than faculty) will be provided by host institution after the arrival at the host university during the activities or programme.






- g. All the expenses to organize the activities or programmes will be provided by host University.
 h. The training programme which is organized by any of the paired university, the training cost will be paid by the host university.
- 2) **In the events of any dispute or differences** arising in the implementation of the MoU, such disputes shall be resolved by mutual discussion and understanding by the head of the institution or a committee jointly appointed by both the universities. All such decisions shall be effective to both the paired universities as per taken decision.
 - 3) **The MoU remains in place for a period of five Years** from the date of signing of the agreement and may be renewed for a further period of Five Years or such time period as agreed by both the parties in writing.
 - 4) The terms of this MoU **may be amended** at any time subject to mutual written agreement such amendment shall be effective from the date on which both the parties execute them in writing.
 - 5) The MoU shall be deemed to have been automatically rescinded after expiry of the MoU period. It is further, agreed that following the termination of the MoU, the paired universities refrain from carrying out the balance of the activities agreed upon in this MoU.
 - 6) Either of the paired universities shall be entitled hitherto shall be entitled **to terminate the MoU** at any time with valid reasons, acceptable in writing to paired universities and in such cases the MoU will terminate six months after the date of written notification or date of expiry of MoU, whichever is earlier. In case of such premature termination of the MoU all rights and obligation of both parties shall automatically ceased except for those covered by written contract including ongoing collaborative activity that cannot longer be cancelled.
 - 7) Termination of MoU shall be done in a cost-effective manner subject to proper turn over and accounting of expenses that may have been incurred, where applicable.


Now, based on the aforementioned promises the parties to put their signatures on this MoU on




