This is to inform you that Regulations for the award of Chancellor Gold Medal has been finalized by the University. The same is attached herewith for ready reference. Further-

1. An amount of Rs. 25000.00 will also be given to the applicant awarded with Chancellor Gold Medal as prize money by the University.
2. The candidate has to apply for the medal in a plain paper accompanied with authenticated documents issued by the Government Officials of respective levels-State Government/Central Government/University.
3. Candidates have to apply for this medal. University will consider only those candidates who will apply for Chancellor Medal.
4. The Size/specification of the medal will be same as the size/specification of Guru Ghasidas Medal.

Kindly communicate these information and provisions of the Regulations to the students of your department accordingly.



## REGULATIONS FOR THE AWARD OF CHANCELLOR GOLD MEDAL

The Chancellor Gold Medal will be awarded in the following manner:

1. That this Medal will be known as the Chancellor Gold Medal, Guru Ghasidas Vishwavidyalaya, which will be mentioned on one side of the Medal.
2. That, this Gold Medal will be awarded to the student on the basis of his/her performance in General Proficiency including Character, Conduct, Excellence in Academic Performance, Extra-Curricular Activities and Social Services on the basis of defined components and calculation table (Table Enclosed).
3. That, on the basis of above defined criteria the Dean of each School of Studies will recommend the name of the best student from the teaching departments in the Universities campus in his/her School of Studies, to the Controller of Examinations by the stipulated date. That the recommendation of the best student should be made along with brief biography of the student and certified documents of his/her achievements.
4. That the marks of the achievements of the candidate shall be counted for the full tenure of his/her programme of study in the university campus.
5. That the marks shall not be given to any such achievement which is a part of the prescribed curriculum of any course of study in the university.
6. That, out of the names suggested by Deans of various Schools of Studies, an advisory committee constituted for such purpose will select the best student for the award of the Chancellor Gold Medal on the basis of marks under the defined components and will send its recommendation to the Vice-Chancellor.
7. That, the Vice-Chancellor would take a decision on the recommendation of the Advisory Committee and accordingly the Chancellors Gold Medal will be awarded in the Convocation or as on the date decided by the Executive Council.
8. That, if there is a tie between two or more students, the Medal will be given to the student senior in age.
9. Other eligibility conditions shall be applicable as per general regulation for the award of Gold Medal prevailing in the university.
10. Merit / performance of the applicants will be decided on the basis of marks obtained in all components and there will be no any qualifying minimum marks overall. However, for the award of Chancellor Medal, it will be mandatory for all applicants to score some marks in Component 1, 2, 3 and 4. The applicant will not be eligible for the award, if he/she will get 0 (Zero) marks in any of the component 1, 2, 3 and 4.
