Important instructions to Applicants

1. All qualified candidates of VRET 2021-22 and candidates under VRET exempted category 2021-2022 only are eligible for appearing online at the stipulated date and time .
2. All applicants seeking admission for PhD programme shall present their research proposal only in advertised areas of specialization.
3. The presentations will be through online mode. Time limit for the presentation is 6 minutes.
4. Applicants ,who have not yet submitted caste certificates, income certificates etc for availing the benefit of reservation are required to submit the documents before the meeting of the DRC. An applicant who fails to submit the required documents before the DRC meeting (i.e. 4th December,2021) for availing the benefits of reservation, shall be treated under unreserved category subject to eligibility.
5. **Interviews/ presentations will be conducted online through Google meet and the candidate has to be prepared for interviews with all necessary arrangements.** University will not be responsible for any technical problems or link failure at the time of interview.
6. Online provisional admission will be given to the selected candidates after the interview on schedule date. Admission will be confirmed by the Department only after physical verification of documents during Pre-Ph.DCourse Work. Mere appearance in the entrance test/ interview or securing a place in merit/ selection list at the time of provisional admission does not entitle an applicant to be considered for confirmed admission to any discipline unless otherwise he/she fulfills the eligibility conditions with necessary supporting documents. If an applicant inadvertently allowed to appear in interview who otherwise does not fulfill the minimum eligibility requirements with supporting documents , he/she cannot, later, use the permission as a right to claim that he/she meets the eligibility requirements of VRET. His/her admission will be cancelled by the university without any prior notice.
7. **The list of selected candidates will be declared on or before 9th December,2021.**
