Minutes of the DRC meeting dated 03/09/2018 for the period 29/02/2018 to 27/07/2018

The first six monthly review meeting of the DRC in Anthropology was organized on 03/09/2018 at HRDC-UGC, GGV from 2.00 PM to 6.00 PM to review the research work progress of three PhD scholars (one VRET, One JRF, one RGNF). Misses Bhumika Tiwary, under VERET did not attend DRC since she is under maternity leave. Professor KKN Sharma, Professor of Anthropology, Dr. H.S Gour Vishwavidyalaya, Sagar, MP who is nominated as external subject expert by HVC, GGV was also present during the presentation. Dr. N Panigrahi, Associated Professor and HoD cum Chairman of DRC and Dr. Subal Das, Assistant Professor, H member of the DRC. The presentations of scholars are as follows

1. Manisha Ghritlehre, UGC NET JRF

This scholar presented her research achievements during the period. She has carried out review of literature, testing of schedule, pilot survey and primary data collection in nine ICDS centers of Gaurella block of Bilaspur district. She has completed data collection from 115 children's representing the above ICDS centers. The committee recommended that the presentation of the achievements should be based on methodologies adopted in the research proposal. The study observation should be presented in depth.


2. Ravindra Singh, RGNF

The scholar presented his research achievements during the period. It was observed that the scholar has completed primary data collection in three villages with respect to the study tools. This scholar has reported that due to the medical requirement in the family point, he was not able to achieve the research target proposed in the last DRC. The committee with reference to the last minutes of the DRC meeting held on dated 28/02/2018 suggested that concentrate primary data collection, data entry, and analysis in coming six months. In addition, he has to also prepare a research paper based on PhD data for communication to UGC listed/referred journals.

3. Saurabh Chaurasia, Research Fellow under VRET

The researcher presented the progress of his research works. In this connection the last DRC meeting which was held on dt.28.02.2018 while reviewing the research achievements of Mr.Chourasia found not satisfactory and suggested to complete the data collection in all the sample villages, complete data entry, data tabulation of all the data collected from study villages by the end of March, 2018. It was observed that Mr. Chaurasia has not followed the given instruction for the same regarding data collection, data entry, and processing and report writings. Under this situation, the committee is not satisfied with his carried out research progress. Therefore, the committee recommends for necessary action as per GGV Ph.D. Regulation/ Provision of the university.




Minutes of the DRC Meeting held on date 28/02/18

- > Bhumika has presented her 4th six monthly report on her progress of work. She explained that she has completed her primary data collection, largely completed the tabulation and written two chapters. Her work is satisfactory.
- > Saurabh Chaurasiya presented the achievements of his research work. It was observed that he is to complete the data collection in one village. It is informed that he has to carry data entry, tabulation of all villages by the end of March 2018.
- > Ravindra Singh presented the achievements of his research work of 2nd six monthly report. It was observed that he has to accelerate the entry, analysis and tabulation of data and also to prepare research paper for communication to the referred and reputed journals.
- > Manisha Ghritlahre has presented her first six monthly report on the progress of work. It was found satisfactory as per UGC regulations she is upgraded from UGC JRF to SRF from 16/11/17.


Mr.Ravindra Singh, RGNF:




Ravindra Singh:
