Subject: Financial Sanction of the research project titled "Plant specific emission pattern of volatile organic compounds(VOCs) with respect to global carbon balance" under the guidance of **Dr. Sudhir Kumar Pandey, Department of Botany, Guru Ghasidas Viswavidyalaya, Koni, Bilaspur-495009, Chattisgarh.**

Sanction of **Science and Engineering Research Board (SERB)** is hereby accorded to the above mentioned project at a total cost of **Rs. 25,00,000/- (Rs. Twenty Five Lakh Only)** with break-up of **Rs. 10,00,000/- under Non-Recurring** and **Rs. 15,00,000/- under Recurring** for a duration of three years. This release is made under Start-Up Research Grant (Young Scientists)- Life Sciences.

4. The Sanction has been issued with the approval of the competent authority under delegated powers and vide Diary No.**SERB/F/714/2014-15 dated 5.05.2014.**

5. Sanction of the grant is subject to the conditions as detailed in guidelines available at www.serb.gov.in.

6.Overhead expenses are meant for the host Institute towards the cost for providing infrastructural facilities and general administrative support etc. including benefits to the staff employed in the project.

7. While providing operational flexibility among various subheads under head Recurring-A, it should be ensured that not more than Rs. 1.5 lakh each should be spent for travel and contingency.
