XI	Yearly Progress report should be submitted at University [for continuation of fellowship for the subsequent year on the basis of performance report]
XII	Copy of Award of degree (M.Phil./Ph.D)/ course completion certificate is required to be submitted at the university. The details of course completion need to be filled by the University at the portal, failing which payment for last 3 months will not be released. Students, who complete the course early, are required to intimate the University immediately.

5. It may be noted that your email id, phone number and the Bank Account number should remain unchanged during the fellowship period.

6. It may also please be noted that the award is liable to be cancelled/ legal action will be taken against the awardee in the following cases:-

- (i) If the awardee is found to be ineligible to receive the award, at any point of time during the entire duration of the fellowship.
- (ii) Misconduct of awardee.
- (iii) Unsatisfactory progress of research work.
- (iv) Any other fellowship is drawn from other source(s)/ drawn fellowship or selected by Ministry of Tribal Affairs for Fellowship earlier.
- (v) Concealment of facts and any other ground of misconduct.

7. The student details is required to be verified and updated at the Canara bank portal by the university.
