FACILITIES FOR STUDENTS

Hostel Facilities

- Four hostels, three for boys and one for girls separately, provide accommodation to 800 approx boys and 430 girls. Two more girls Hostels of capacity 200 will be available very soon for allotment. Vishwavidyalaya faculty member as Warden supervises each hostel. Admission in hostels is based on merit as per university rules and the students will be required to apply in the prescribed application form.

Fee / Hostel charges

For admission in Girl's Hostel and Swami Vivekanand Boy's Hostel

- Hostel Fee Rs. 8750.00 (Rs. 6750.00 Yearly + Rs. 2000.00 Refundable Hostel Caution Money) to be deposited in the University General Account
- Mess Fees Rs. 12070.00 (Rs. 8070.00 Mess Charges for three months + Rs. 4000.00 Refundable Caution Money) to be deposited in the Hostel Mess Account.

For Admission in New Hostels

- Hostel Fee Rs. 12000.00 (Rs. 10000.00 Yearly + Rs. 2000.00 Refundable Hostel Caution Money) to be deposited in the University General Account
- Mess Fees Rs. 12070.00 (Rs. 8070.00 Mess Charges for three months + Rs. 4000.00 Refundable Caution Money) to be deposited in the Hostel Mess Account.

<u>UGC Guidelines on Safety of Students on and off Campuses of Higher</u> <u>Educational</u>

- HEIs can play a significant role in ensuring the safety of the students by putting in place foolproof mechanisms and impregnable standards of safety. The key lies in institutionalizing the best practices and standard operating procedures that can substantively protect students from any threats and assaults, physical, social or psychological. Given below are some of the concerns that should be materialized by HEIs in the interest of students and institution
- Any physical infrastructure housing students, whether HEI or hostels, should be secured by a boundary wall of such height that it cannot be scaled over easily. In order to further fortify it, a fence of spiraling barbed wires can be surmounted on the wall so that unauthorized access to the infrastructure is prevented effectively. The entry points to such housing units should be restricted to three or less and they should be manned by at least three security guards, sufficiently armed, CC TV cameras, identity verification mechanism and register of unknown entrants/visitors with their identity proofs and contact details. At least one woman security personnel should be deployed at such entry points so that physical security check of girl students or visitor can be undertaken. The bags and other belongings of students/visitors can also be examined, manually and/or by metal detectors, in order to secure a weapon-free and violence-free campus.
- On-campus medical facilities should be made available to student.

Code of Conduct for Students

The students are admitted to Guru Ghasidas Vishwavidalaya to achieve excellence and shape their character to become responsible citizens. They must realize their responsibility towards the Vishwavidalaya and to its components like faculty, staff and fellow students. Failure to maintain a good standard of conduct shall result in disciplinary action.

Attendance: 75% attendance is compulsory in each subject

MISCONDUCT: Any of the following activities (but not limited to these only) will be treated as misconduct

- Disruption of teaching activities or disturbing the learning process of other students on the campus.
- Any act on the part of the students, which disrupts functioning of the university, endangers health and safety of campus residents and da mages Vishwavidalaya properties.
- Cheating in examination and supplying of false documents / information in order to seek any consideration / favour from the University.
- Possession or consumption of intoxicating beverages on the campus.
- Failure to return back loaned material, settle University dues.
- Possession of weapons.
- Use of unparliamentarily language while in conversation with Vishwavidyalaya Staff and fellow students.

DISCIPLINARY ACTION

- A warning by the authorities.
- Suspension from a particular class.
- Suspension / expulsion from the University. Suspension of campus privileges e.g. hostel, accommodation etc.
- Withholding of examination result or withdrawal of awarded diploma / degree certificate.
- Any other disciplinary action deemed appropriate by the University authorities.

FACULTY(STAFF) DETAILS

EXAMINATION AND EVALUATION

- **1**. The academic performance of a candidate shall be evaluated in respect of the courses of study prescribed for each semester through the evaluation The evaluation of students admitted in any of these Programmes shall be based on
 - (a) End Semester Examinations, and (b) Continuous Internal Assessment.
- 2. Out of the total marks, 70% shall be allotted for the end semester examinations and 30% shall be allotted to continuous internal assessments during the semester. The scheme of internal assessment shall be as :- There will be two compulsory internal exams of 15 marks each. If a student fails to give internal exam because of some emergencies / unforeseen situations, the Dean of the School may permit the student to appear in the special internal exam on the satisfaction of the reason mentioned by the student for not appearing in the regular internal exam.
- **3**. The end semester examinations will be held on such dates as may be notified by the appropriate authority of the University.
- **4**. The minimum percentage of marks to pass the courses in each semester shall be 40% in each paper (course).
- **5**.All Programme shall have a specified number of credits in each semester. The number of credits along with grade points that the student has satisfactorily cleared shall measure the performance of the student. Satisfactory progress of a student is subject to his/ her maintaining a minimum Cumulative Grade Point Average (CGPA), as well as minimum grades in different courses of the programme as given in table-1 which a student if obtains is eligible for the award of degree.
