FOR B.TECH. ADMISSION IN 2022-23 AGAINST A FEW VACANT SEATS OF UR/SC/ST/EWS CATEGORY IN THE SCHOOL OF STUDIES OF ENGINEERING & TECHNOLOGY, GGV

A Special offline counseling for B.Tech 1st year admission against few vacant seats of UR/SC/ST/EWS category for session 2022-23 is to be held on 16th January, 2023. Candidates are advised to go through the details given below:

Reporting Place: E-classroom, New IT Building, Guru Ghasidas Vishwavidyalaya

The guidelines of this Special Offline Counseling process are as below:

- 1. Eligibility:** Candidates, who satisfy the eligibility criteria laid down by JOSAA/CSAB- 2022 in its **Business Rule** as available on the www.josaa.nic.in are eligible to participate Special Offline Counseling process for admission in BTech program.
- 2. No application from already admitted students of BTech 1st year of Guru Ghasidas Vishwavidyalaya will be entertained under any circumstances.**
3. Candidates have to report at E-classroom, New IT Building, Guru Ghasidas Vishwavidyalaya on 16th January, 2023 at 9.30am onwards.
- 4. The admission will be given on the first come-first serve basis provided the candidate should have the documents as laid down in point no. 09 below.**
5. Candidates have to pay the B.Tech. first semester fee amount Rs. 16700/- (Rupees Sixteen Thousand and Seven Hundred) immediately through online mode only. **No CASH fee submission is allowed.**
6. Seat to a candidate will be confirmed (if allotted) after the payment of the admission fee at that time only, failing which the candidate will lose the seat and further will not be considered for seat allotment.
7. Seats once allotted will not be reverted back in any circumstances.
8. There will be no refund of fees for candidates who are allotted a seat through University level/Spot Counselling and also at any stage of the counseling process after fees submission.

9. Documents Required at the Time of Admission:

- a) Candidates have to submit the B.Tech. first semester fee amount Rs. 16700/- (Rupees Sixteen Thousand and Seven Hundred) at the time of offline counseling and therefore are directed to come with mobile and ATM for online payment of fee. Admission committee will collect the semester fee through QR code provided by the University to the departments. In case of any technical problem or fault, fee may be collected through ATM SWIPE Machine with the permission of Dean, SoS E&T. In case of failure of these two facilities, SBI Collect may be used for collection only after approval of the HoD concerned.
 - b) Original JEE (MAIN) 2022 ADMIT CARD, JEE(MAIN) 2022 SCORE CARD.
 - c) Original Class X (High School) Board Certificate as a proof of date of birth.
 - d) Original Class 12th Marksheet.
 - e) Transfer, Character and Migration Certificate from the last school/college (All in original).
 - f) Certificate of category (OBC/SC/ST), if applicable, issued by the competent authority in the format prescribed by JOSAA-2022 (Central Government Formats).
 - g) Latest Income certificate for OBC-NCL candidate (issued on or after 01/04/2022).
 - h) Certificate for Person with Disabilities (PWD), if applicable.
 - i) One set of self attested copy of all the above certificates.
 - j) Medical certificate from a duly competent authority.
 - k) Gap certificate, if applicable (Original).
 - l) Six passport sized photo.
10. The decision of Vice-Chancellor, Guru Ghasidas Vishwavidyalaya, Bilaspur(C.G.) in respect of the Special Offline Counseling process for B.Tech. First Year admission for the session 2022-23, shall be final and binding.
