It is hereby informed to all the VRET 2022-23 qualified applicants and VRET exempted category applicants that the admission process shall be conducted in the following manner -

- a. List of VRET/VRET-Exempted candidates and access of online forms will be provided by the Academic Section to the departments on or before 21.04.2023.
- b. Departments will download application forms and supporting documents of VRET qualified/VRET-Exempted candidates online. After checking their eligibility (through Admission Committee) HoD concerned will send interview letters through email and through speed/registered post to the eligible candidates and will arrange interview/presentation in blended mode for such candidates between 10.05.2023 to 15.05.2023. However, candidates interested to appear in interview online must have got prior approval from the HoD concerned for the same.
- c. Departments will prepare the list of candidates called for interview and will publish it on website with date of interview. List of VRET qualified candidates may be uploaded on 26.04.2023 and VRET Exempted category candidates on 01.05.2023.
- d. In their call letters the HoD concerned will mention that the candidate has to come with following documents to attend the interview with a presentation/research proposal-
 - 1. 10th (HSC) Mark sheet (Mandatory)
 - 2. 12th (HSSC) Mark sheet (Mandatory)
 - 3. UG Mark sheet (Mandatory)
 - 4. PG Mark sheet (Mandatory)
 - 5. Transfer Certificate/ College Leaving Certificate (Optional), if available
 - 6. Caste/Category/PWD Certificate, if any (Mandatory if applied under any category)

- 7. Income certificate for OBC, if any
- 8. If applied for VRET Exempted, then one document in support of exemption claimed and NoC (mandatory)
- e. Admission Committee of the department may verify the documents of the candidates appeared for interview.
- f. Candidates will attend the interview on scheduled dates and will give their presentation before the DRC concerned. No TA/DA will be paid to the candidate by the University.
- g. A candidate appearing in a subject other than his PG subject has to submit the proposal/presentation with justification for such change to DRC. All such candidates must submit the proposal to the HoD concerned well in advance for its evaluation by the members of DRC concerned.
- h. Departments will prepare merit list of the selected candidates according to the provisions of Ph. D. Regulations 2023 and VRET 2022-23 Admission Procedure and will declare the result/list of selected candidates on or before 16.05.2023 on university website. Department will also send emails to the selected candidates for information about their selection.
- i. Selected candidates may submit their prescribed admission fee online (www.ggu.ac.in) on or before 20.05.2023 and may submit a copy of receipt to the HoD concerned to confirm his/her seat for admission. However, all candidates shortlisted for admission have to report the department with all original documents on or before 30.05.2023 and have to submit their Transfer Certificate (TC) in original to the department. In case, the selected candidate will not report the department on time and will not submit the TC, then the department concerned may cancel the admission of such candidate and may allow the admission of other candidates from waiting list.
- j. Pre-Ph. D. Course Work of admitted students shall be started from 03.07.2023.
- k. All the guidelines for Admission Procedure and Ph. D. Regulations are available on university website <u>www.ggu.ac.in</u>. Admission Committee and DRC of the departments have to follow the guidelines and provisions of Ph. D. Regulations 2023 for all above said process.
- I. Candidate admitted to Pre-Ph. D. Course Work may claim their fellowship from the date of commencement of classes of Pre-Ph. D. Course Work, if eligible.
