## **Office Memorandum**

Bilaspur, Date- 12.11.2021

In continuation to even OMs issued earlier, it is informed to all the VET/VRET 2021 applicants that the admission process shall be conducted in the following manner now-

- 1. Last round of VET online counseling will be conducted from 16.11.2021 to 20.11.2021.
- VET Online counseling system will be stopped after 21.11.2021 and offline/spot counseling facility will be available for the applicants in the following manner
  - a. In case, vacant seats will be available on 21.11.2021 in a programme and some candidates will also be available in the merit list of that programme then the concerned Department may give offline admissions to those applicants on the basis of their merit from 22.11.2021 to 25.11.2021.
  - b. In case, vacant seats will be available on 21.11.2021 in a programme and no candidate will be available in the merit list of that programme, then the concerned Department will publish the list vacant seats on website www.ggu.ac.in and Departmental Notice Board on 22.11.2021 and invite applicants from the interested candidates to transfer their applications in their department against those vacant seats. Interested candidates may submit their request for transfer of applications in a plane paper (Online/Offline) with supporting documents and copy of Online Application Form to such department on or before 25.11.2021.

Departments will give offline admissions to such applicants on the basis of their merit on 26.11.2021.

- c. Last date of VET 2021-22 admissions will be 26.11.2021.
- d. Candidates admitted in this process may submit their fee online on website www.ggu.ac.in.
- 3. VRET Admission will done in the following manner
  - a. List of VRET/VRET-Exempted candidates and access of their online forms will be provided by the Academic Section to the departments on or before 18.11.2021.
  - b. Departments will collect the supporting documents from VRET qualified/VRET-Exempted candidates online, will verify those documents, will send interview letter through Email and through speed/registered post to the candidates and will arrange online interview for such candidates.
  - c. Candidates will attend the interview online and will give their presentation online.

- Departments will prepare merit list of the selected candidates according to the provisions of
  Ph. D. Regulations 2018 and VRET 2021 Admission Procedure and will declare the result/list of
  selected candidates on or before 09.12.2021.
- e. Selected candidates may submit their prescribed admission fee online (www.ggu.ac.in) on or before 15.12.2021.
- f. Pre-Ph. D. Course Work of admitted students shall be started from 20.12.2021.
- 4. Admissions will be given to the wards of employees against supernumerary quota seats by the departments on or before 26.11.2021 on the basis of their merit and fee shall be collected online (www.ggu.ac.in).
- 5. Online classes may be started from 29.11.2021 for newly admitted students.
- 6. No fresh application shall be entertained in the above said process.
- 7. Dean of the concerned School shall coordinate the admission process of the departments of their school.
