
ORDER

Terms and Conditions:


1. The service conditions of this appointment will strictly be governed by of SERB (DST), Govt of India.

3. The JRF shall devote full time to the service of the Project Work and Shall not accept or hold any appointment paid or otherwise or receive any emoluments, salary, stipend, other fellowship etc from any other source during the tenure of the fellowship.
4. Any absence from duty will amount to proportionate deduction of fellowship.
5. In addition to his normal duties may engage to such other duties as may be assigned to him by the PI.
6. The fellowship may be terminated at anytime without assigning any reason by competent authority and the decision in this regard shall be final.
7. The candidate shall be required to join in the institute of Pharmaceutical Sciences within **15 days from issue of the letter.**
8. This appointment of JRF shall be purely temporary and co-terminus with the project.
