- 5. In addition to his normal duties may engage to such other duties as may be assigned to him by the PI.
- 6. The fellowship may be terminated at anytime without assigning any reason by competent authority and the decision in this regard shall be final.
- 7. The candidate shall be required to join in the institute of Pharmaceutical Sciences within 15 days from issue of the letter.
- This appointment of JRF shall be purely temporary and co-terminus with the project.
