The communication of the University vide letter No. 3004/Est/Adm/2018 dated 09.11.2018 was also perused by the Executive Council.

The Executive Council took a serious note of the conduct of Prof S.N. Saha and expressed displeasure.

It was **Resolved that** a warning letter be issued to Prof S.N. Saha, mentioning that in case of any such misconduct in future, he himself will be liable for appropriate disciplinary action as per rules.
