Subject: Students' Council Election -2012, Distribution of the Number of Elected Representatives

Dear Madam/Sir,

With reference to above and the relevant provisions of Guru Ghasidas Students' Council Election 2011 (as amended), the distribution of 20 students to be elected as representatives is being done in the following manner.


1. Each School of Studies shall have at least one representative, subject to fulfillment of eligibility criteria for candidates, as contained in Clause 9 of the Regulation.
2. In case number of Schools is less than the number of representatives to be elected, the remaining seats will be distributed on the basis of proportionality to the strength of the students, so far as practically possible.

Therefore, on the basis of the information received from the Departments and the manner mentioned above, the distribution of 20 students to be elected as representatives is as under:
