**Notification**

Whereas, the term of Dr Lakshman Chaturvedi as first Vice-Chancellor of Guru Ghasidas Vishwavidyalay, Bilaspur (Chhattisgarh) was came to an end on 28.02.2014 as per Section 44 (a) of the Central Universities Act 2009 .

Whereas, it is mentioned in Statute 4(2) that the term of Office of the Pro-Vice-Chancellor shall be such as may be decided by the Executive Council but is shall not in any case exceed five years or until the expiration of the term of office of the Vice-Chancellor.

Whereas, the term of office of Dr. Lakshamn Chaturvedi, the then Vice-Chancellor was ended on 28.02.2014, 06.00PM (at the end of office hours) hence the term of Dr. M. S. K. Khokhar, the then Pro-Vice-Chancellor was also expired on the same date and time as both are co-terminus as per UGC regulations 2010, R 7.2.0.

Whereas, it is provisioned in the Statute 2(7) that if the Pro-Vice Chancellor is not available, the senior- most Professor shall perform the duties of the Vice-Chancellor until a new Vice-Chancellor assumes the office. However the former Vice-Chancellor Dr. Lakshamn Chaturvedi handed over the charge of Vice-Chancellor to Dr MSK Khokhar (a retired Professor) in contravention to statute 2 (7) made under the Central Universities Act 2009 .

Whereas the Ministry of Human Resource Development (MHRD) vide letter no. 49-2/2014-Desk U dated 10.11.2014 directed the Registrar to appoint senior most professor in terms of statute 2 (7) as Vice-Chancellor of Guru Ghasidas Vishwavidyalay, Bilaspur and to relieve Dr M S K Khokhar ( a retired Professor ) from the post of the Vice-Chancellor .

Whereas in compliance of above direction of MHRD letter dates 10.11.2014, the Registrar has issued a notification no. 855/Admn/Estt/2014 dated 11.11.2014 declaring thereby that Dr. S. P. Singh, Senior-Most-Professor of the University shall perform the duties of the Vice-Chancellor of Guru Ghasidas Vishwavidyalay, Bilaspur . As per the directions Dr. S. P. Singh, Senior Most Professor of the University assumes the office of the Vice-Chancellor on 11.11.2014 (Forenoon) and discharging the duties.

Whereas, Dr. M. S. K. Khokhar was working as professor in Guru Ghasidas Vishwavidyalay, Bilaspur and he was superannuated , officially , from the post of Professor on 31.05.2013 after completing 65 years of age. Meanwhile, he was reappointed as Professor, Department of Rural Technology by the Executive Council in its meeting held on 19.04.2013. The same has been notified by the Administration on 31.05.2013 vide order no. 778/Rec/Admn/2013 Dated 31.05.2013 but Dr. M.S. K. Khokhar did not give his joining as reappointed Professor in the Department of Rural Technology till 16.11.2014 . However, Dr. M. S. K. Khokhar has reported to the Department of Rural Technology on 17.11.2014, after 18 months of reappointment.

Whereas, the Selection Committee's recommendations, when approved by the Executive Council/ by the Vice Chancellor on behalf of the Executive Council, shall remain valid for a period of one year from the date of such approval, as per provisions of Ordinances approved by the Executive Council in its meeting held on 13.07.2009 and UGC Model Ordinance 11 (23).

Therefore, in the light of above facts it is hereby notified that Dr. M. S. K. Khokhar is not holding the post of Professor or any other working positions in this University.
