# 1.1 For Temporary Assistant Professor (University Teaching Department)

**Fixed** Pay - 25000/-p.m

**Essential (As per UGC norms):** 

## Eligibility (A or B):

- **A.** i) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university.
  - ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET:

Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:-

- a) The Ph.D. degree of the candidate has been awarded in a regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;
- e) The candidate has presented at least two papers based on his/her Ph.D work in conferences/seminars sponsored/funded/supported by the UGC / ICSSR/ CSIR or any similar agency.

The fulfilment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

Note: NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

OR

**B.** The Ph.D degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

Fixed Pay -25000/- p.m.

# i. Essential,

B. E. / B. Tech. / B. S. and M. E. / M. Tech. / M. S. or Integrated M. Tech. in relevant branch with first class or equivalent in any one of the degrees.

# 1.3 For Temporary Assistant Professor (Department of Education)

**Fixed** Pay – 25000/- fixed salary per month

# 1.3.1 For Assistant Professor (Department of Education for Performing/Fine Arts)

**Fixed** Pay – 25000/- fixed salary per month

- 1. Visual Arts :- Post Graduate degree in fine arts with minimum 55% marks or

For specialization in VI area, Masters degree in school subject will be required. Similarly for specialization areas in Mental Retardation and Hearing Impairment, Masters Degree in Psychology, Child Development/ Human Development, Sociology, Linguistics and Education will be preferred.

- 1. Online applications are invited from Eligible and interested candidates for Appointment as Teachers on Purely Temporary Basis (initially for six months or till regular appointment whichever is earlier) for the remaining period of Academic Session 2020-21 along with attested copies of Mark-sheets/Certificates/Degrees of academic qualifications and experiences, till 21-12-201 at 11:59 PM at registrar@ggu.ac.in.
- 2. For shortlisted candidates, the interview shall be conducted through online/virtual mode. It is expected that the candidates must be well versed with GOOGLE MEET / ZOOM application.
- 3. Any further communication regarding dates of interviews and other information shall be made through emails to the candidates and updated on the University website, therefore the candidate must provide his/her valid & working telephone number and emails correctly and clearly on the prescribed space. In case of any ambiguity his/her candidature shall not be considered and University shall not be liable for calling him/her for interview.
- 4. Candidate must enclose a non-refundable application fee of Rs. 100 (Exempted for SC/ST/PH candidates) in the form of receipt of fee deposited online, through University portal.
- 5. This offer for the temporary job in the University will not confer any right on invitee to claim regular employment to any post.
- 6. The candidates shall be required to join his duties on purely temporary basis in the University within 07 days from the date of offer letter.
- 7. The invitee shall devote his/her whole time to the service of the University and shall not engage directly or indirectly to any other employment or any trade or business or other remunerative work.
- 8. Any absence from duty will amount to proportionate deduction of remuneration.
- 9. The invitee may be discontinued from services at any point of time without assigning any reason. No prior notice in this respect will be required.
- 10. Infringement of any terms and conditions specified herein above, would called for an action.
- 11. In case of any dispute the decision of the Vice-Chancellor will be final and binding.
- 12. Relaxation and Reservation will be given as per GOI/UGC Rules to all the persons belonging to SC/ST/OBC/EWS category.

- 23. Number. of posts advertised may be treated as tentative. The University shall have the right to increase/decrease the number and/or nature of posts at the time of selection and make appointments accordingly.
- 24. The prescribed qualifications and experience will be minimum and the mere fact that a candidate possessing the same will not entitle him for being selected.
- 25. The University may Draw a panel in the form of a waiting list to fill up a post. In case a candidate on higher merit regrets to join within a period of 06 months or resigns/ dies after joining, within a period of 06 months, the offer shall be made to next candidate on the merit, if otherwise in order, to reduce the delay in filling up of the vacancies.
