### Information details for submitting application for Muktibodh Chair

Guru Ghasidas Vishwavidyalaya invites applications for nomination as **MUKTIBODH CHAIR** constituted in the honour of Late Shri Gajanan Madhaw Muktibodh, who was one of the most prominent Hindi poet, essayist, literary and political critic, and fiction writers of the 20th century.

#### A. Academic Functions

- To coordinate and to provide a think tank in the area of studies drawing expertise and inputs from academics experts from other sectors like Government and other National/International NGOs.
- To provide a forum for inter-university/inter-collegiate PG and research level dialogues, discussion meetings, summer/winter institutes, involving other universities/autonomous institutions/PG centers.
- To design and execute capacity-building programmes for teachers in higher education focused towards the designated discipline of the Chair.
- To strengthen the role of Universities/Academics in Public Policy making.
- To conduct short-term courses in the concerned disciplines.
- Publications of proceedings
- There will not be any full-time regular course leading to under-graduate or post-graduate degree except for the Ph.D. programme and related course works.

#### B. Qualifications, Experience for the Chair

Qualification/Experience:- Eminent Scholar of outstanding track record in the relevant areas of studies atleast for last ten years.

#### C. Consolidated Remuneration

The Chair will carry a consolidated honorarium Rs. 01 Lac/month and Contingency Rs. 12000/year. In case of superannuated Professors, the GOI Rules for re-employment shall apply.

#### **D. Tenure of Appointment**

The term of the Chair is for one academic year but may be extended to three academic years by mutual consent one year at a time. In special circumstances, a short term of six months will also be considered.

#### **E. Facilities to be offered during the tenure**

The selected person for Muktibodh Chair will be entitled to the following facilities:

Economy class *to and fro* air fare for the Chair holder, spouse and dependent children will be provided only once during the tenure of the Chair. Free furnished accommodation at Guru Ghasidas Vishwavidyalaya campus for the entire tenure. However, recurring costs of the utilities shall be borne by the Chair. Medical facilities for the Chair, spouse and dependent children will be provided as per University norms. Domestic air-fare for the lectures, workshops and for any other travel connected with the Guru Ghasidas Vishwavidyalaya sponsored research and training programmes in the relevant area. Secretarial support (01 Peon+01 Stenotypist/Typist) will be provided.

#### **F. Minimum Output Expected**

The Chair would be expected to give public lectures on the theme related to Late Shri Gajanan Madhav Muktibodh and his life at Guru Ghasidas Vishwavidyalaya and its out-reach institutions in the states of India.

During the tenure he/she would also organize Consultations and Seminars at Guru Ghasidas Vishwavidyalaya and its out-reach Institutions.

He would also organize Workshops around ideas presented during his lectures at Guru Ghasidas Vishwavidyalaya and its out-reach organizations.

The Chair is also expected to prepare two or three Technical Papers or Research Studies in reputed journals during his tenure.
