- 2. Bulk delivery should be made from 10 days from the date of final confirmation on the proof.
- 3. Liquidated Damages: 0.5% liquidated damages per week towards late delivery of printed envelopes subject to a maximum of 5% of the total order value.
- Payment: 100% payment will be made after supply and delivery of ordered quantity of printed envelopes at our end in good condition. No advance payment request will be entertained.
- 5. CST/VAT will be paid extra, if applicable provided it is made clear in the quotation.

- 6. **Discount, if any**: Special concession/discount applicable for Educational Institutions, if any, must be clearly mentioned at the time of submission of quotation.
- 7. The rate should be quoted on F.O.R. University Campus, Koni, Bilaspur basis. No packing/forwarding charges will be paid extra.
- 8. **Delivery period**: The envelopes to be delivered within 20 days from the issue of P.O.
- 9. University will not be responsible for any postal delay or non-receipt of the tender.
- 10. Unsealed quotations will be rejected and quotations must reach on or before the due date through Speed post/ Registered post/courier only.
- 11. University reserves the right to accept or reject any quotation without assigning any reason thereof.
- 12. The rates quoted should remain valid for six months from the date quoted.
- **13.** Samples of the envelope paper printed by the bidder are to be submitted with the bidder's signature and seal. The same quality should be used for bulk printing.
- 14. Printers can meet the O/o Assistant Registrar (Stores) for sample inspection.
- 15. All disputes will be subject to Bilaspur jurisdiction only.
