Sealed quotation are invited for construction and uploading of Website under NSTMIS (DST) project. Interested parties may submit the possible rates for execution of the work mention below to the Undersigned by Registered/ Speed post only on or before 30th October 2014 up to 5:00 pm. The quotation will be opened on 30th October 2014 at 5:00 pm before the representative of the bidder, if available.

Introduction of the Website:

Journal Quality Indicator of India (JQII) is an outcome of research project to introduce a mechanical system for evaluating quality of Indian journal. The main aim of this project are:

- To create a web-enabled decentralized system to incorporate journals and then evaluate according to their qualitative characteristics.
- To implement the techniques mentioned in Evaluation Techniques tag.

There will be three user level of access for the software:

- Guest User
- Registered User (referred to as 'User' in the document)
- Administrator

Some of the functionalities given to the user will be required to be approved by the administrator.

The details are mentioned below along with all the other features.

Software Features & Specifications

The software should have the following features:

S.No.	Feature	Specifications
1	Adding user	Provision for Creating new User Accounts for the administrator
2	Journal Database creation	Developing software, which could be used to create a Database for 1000+ journals with nearly 100+ variable fields for data capturing. These journals can be added by either admin or user
3	Journal Modifying/Deletion	Creating an option for the user to delete, modify the journal entries & its respective fields
4	Journal add/delete approval	Implementing a check on the Journal deletion process for administrative approval
5	Journal printing	Creating an option to print the journal entries made by the users
6	Latest journal added	Provision for displaying the latest journals added in a predefined space automatically
7	Journal Scoring mechanism	Developing Score Sheet for every field (manual & Automatic both) to be used for counting Journal Value.
8	Journal Status	Enabling different status to the added journals e.g. Marking it as a Live Journal
9	Publisher adding	Provision for adding a new publisher details for the administrator
10	Publisher edit/delete option	Any added Publisher's details could be added or deleted by the user

11	Publisher add/delete approval	Implementing a check on the publisher deletion process for administrative approval
12	Suggest a Journal	Journal Suggestion process where any registered user or guest user can suggest the administrator a journal to be added to the portal. The journal will be added on the approval of the administrator
13	Publisher registration	Publisher registration process is where any publisher can initiate a request the administrator to get registered on the portal. The publisher will be added on the approval of the administrator
14	User Interfaces & views	Developing Different Front end for End- Users as well as Administrator
15	Exporting Journal Details	Creating a mechanism to export various journal entries in CSV format
16	Back up & restore mechanism	Creating a mechanism for taking periodic backups at various point and also, a feature to restore the previous taken backup
17	Responsive UI	The user interface of the software should be device independent i.e. have different views for mobiles, tablets and computers
18	Support & Up gradation	One year Logistic and technical support for bugs and up gradation issues
