LIMITED TENDER INQUIRY

GENERAL TERMS AND CONDITIONS OF THE SUPPLY

1. **The sealed quotation be superscripted with**

“Tender for supply of Equipments under Research Project”.

2. **Quantity:** The quantity mentioned (in page-1) are indicative and may be altered at the time of placing the purchase order.
3. **Product Leaflet/ Handbook:** Duly certified copy of the “**Manufacturer’s Product Technical Brochure / Leaflet /Handbook (Printed copy)**”, containing detail specifications, description etc. of the equipment/ instrument, must be submitted along with the tender, by the bidder. Without Manufacturer’s Brochure/Leaflet/ Handbook (self attested)the tender may be technically disqualified. The offered specifications of the bidder and the specifications in the Manufacturer’s leaflet/handbook/Brochure must match. The quoted specifications must fulfill the desired specifications given by GGV.
4. **Authorization Certificate:** The bidders have to submit, authorization certificate(self attested) issued from the Principal Manufacturer of the Equipment/ instrument.
5. **PAN and TIN/ registration certificate:** The tenderer must have valid PAN and TIN/ registration certificate etc. The relevant documents as proof (self attested) must be submitted with the tender.
6. **Discount /Concession:** Special concession/discount (if any) applicable for the educational institutions/ Govt organizations etc. must be clearly mentioned in the price bid.
7. **Excise duty exemption:** The University is exempted from Custom/Excise Duty by DSIR, Govt. of India vide letter no. TU/V/RG-CDE(710)/2010 dated 19-1-11. The exemption certificate of the same shall be issued by the University to the supplying firm (on demand), at the time of supply. Bidder must clearly mention if any basic custom duty/ excise duty etc is chargeable, in spite of the fact that the GGV is eligible for its exemption against the DSIR certificate.

8. **Rate Contract under DGS&D etc.:** If the tender items are under the rate contract of DGS&D/Govt body/organization, then the quoted price in the tender, should not be more than those approved rates under the rate contract.
9. **FOR GGV; Packing forwarding and transit insurance:** The rate in the tender should be quoted on F.O.R, Guru Ghasidas Vishwavidyalya campus, Koni, Bilaspur(C.G.), basis. The equipments /instruments supplied must be in good condition. No packing/ forwarding, loading-unloading, transit insurance charges will be paid extra to the bidder by GGV. All extra charges have to be borne by the supplier/bidder only.
10. **No Installation charges:** The Equipment/ Instrument must be delivered, installed and demonstrated without any extra charges from the GGV.
11. **Validity of the offered Rate:** The quoted rate should be valid for a minimum period of 90 days from the date of opening of the price bid.
12. **Delivery period:** The Equipment/ Instrument, ordered will have to be delivered and installed in the department of Forestry, Wildlife and Environmental Sciences, Guru Ghasidas Vishwavidyalaya, Koni, Bilaspur-495009 (C.G)” at GGV, within **90 days** from the issue of the Purchase Order.
13. **Warranty:** At least **one year** comprehensive on-site warranty shall be applicable to the supplied equipment/instrument for all manufacturing defects from the date of satisfactory installation, commissioning, demonstration by the supplier and acceptance by GGV.
14. **Performance security:** The successful bidder must submit performance security of 5.0% of the ordered value, on the goods/services supplied irrespective of the origin, within fifteen days of issue of purchase order in form of Demand Draft/TDR/Bank guarantee from any nationalized bank. Otherwise, the same amount will be deducted from the billed amount. On satisfactory completion of the warranty period of 01 year or more period as offered by the bidder, the performance Security will be released without any interest, on demand of the supplier.




15. **Payment:** No advance or part payment shall be made by the GGV, prior to supply of the goods as per PO. Payment to the firm shall be made, only after the successful supply in good condition, installation and demonstration of the equipment/ instrument at GGV.
16. **CST/VAT etc:** CST/VAT / other taxes (if chargeable) must be clearly and separately mentioned in the quoted rates along with the tender. If no extra taxes are admissible then tenderer must mention "No extra taxes" in their price bid. However the chargeable taxes etc. (if mentioned in the tender) shall be paid by GGV as per the prevailing government rules only. No taxes etc. shall be paid if not mentioned in the bid.
17. **Offer after due date:** GGV shall not be responsible for late postal delivery. Thus any offer received late will not be accepted by GGV.
18. **Rights of GGV:** GGV has all the rights reserved to accept / reject (any /all) the tenders and not to procure any/all the equipments/instruments, without assigning any reason(s) thereof.
19. **Dispute :** In case of any dispute the decision of the Vice Chancellor, GGV, Bilaspur(C.G.) shall be final and binding upon the bidder/supplier.
