"Proof of Registration Certificate of Firm and Original Equipment Manufacturer (OEM) Authorization letter (as and where applicable) should be attached by the Bidder."

To be read as

"Proof of Registration Certificate of Firm and Original Equipment Manufacturer (OEM) Authorization letter (as and where applicable) and complete specification of product going to supply should be attached by the Bidder."

iii. Criteria 2.5 which is currently mentioned as

"Copies of the audited balance sheet of the vendor/bidder for the last three financial years, details of Permanent Account Number, ITR (Income Tax Return) for last 3 financial years and Certification for ISO must be attached by the Bidder of relevant
