- 4. Discount, if any: special concession/discount applicable for educational institutions, if any, must be clearly mentioned at the time of submission of quotation

- 12. Warranty: one year comprehensive on-site warranty shall be applicable to the supplied goods for all manufacturing defects from the date of satisfactory installation, commissioning, demonstration and
- 13. Performance security: the successful bidder must submit performance security of 5.0% of the ordered acceptance value, on the goods/services supplied irrespective of the origin, within fifteen days of issue of purchase order in form of Demand Draft/TDR/Bank guarantee from any nationalized bank. Otherwise, the same amount will be deducted from the billed amount. On satisfactory completion of the warranty period of 01 year (12 months), Performance Security will be released without any interest on demand
- 14. Payment: 100% payment will be made after supply and installation of ordered quantity of article at our end in good condition. No advance or partial payment request will be entertained
