Candidates are advised to keep with them required fees; all documents/certificates (Especially valid caste certificates and others) in original and Xeroxed copies. A candidate will not be allowed to leave counselling to collect any certificate once counselling starts; he/she will be treated as NON INTERESTED and next candidate will be considered immediately.

Important instructions to candidates

- i. The candidates who have appeared in VET 2013 are eligible for Reporting cum Counselling on the basis of VET 2013 merit
- ii. The admission will be based on VET 2013 merit.
- iii. Candidates will bring with them following documents in originals and a photocopy (self Attested) at the time of counselling
 - a. Mark sheets of 10th, 12th and Graduation from recognized board/ University.
 - b. Valid Caste certificates (if applicable) as per Government of India rules. For OBC candidates, a non creamy layer valid certificate is a MUST as per Government of India rules.
 - c. VET 2013 admit card
 - d. Any other document which they wish to show
 - e. Gap certificate, if applicable.
- iii. At the time of counselling, the candidate must have qualified eligibility examination. Mark-sheet / result should be ready with the candidate.
- iv. After the candidate is recommended for provisional admission, he/she will have to fill up challan form for depositing fees for the course. The First Year fees is Rs. 21455/. The fees will be deposited at the Bank Counter in the University. The candidate will submit one copy of the challan after depositing fees in the Bank to the counselling team failing which his/her admission will be cancelled and admission will be given to next candidates.
- v. The fees can be deposited by cash or demand draft in favour of The Registrar, Guru Ghasidas Vishwavidyalaya, Bilaspur C G payable at Bilaspur only. The required fees should be ready with a candidate once he/she is recommended for provisional admission.
- vi. The admission of a candidate can be cancelled due to ineligibility of the candidate or due to any other reason including human error in preparing list at any time even during the course.
- vii. It is the responsibility of the candidate to remain alert about all announcements made in the counselling hall regarding counselling.
- viii. Mere appearing in Reporting / counselling does not entitle a candidate for admission in the course. It is subject to fulfilment of all criteria.
