With reference to above, this is to inform you that the Counselling for admission to Pre- PhD course will be held on 25th July, 2014, Friday in the Department of Management Studies as per the programme given below:

- 1. Reporting and Registration: From 1000 Hrs. to 1200 Noon**
- 2. Verification of Documents: From 1100 Hrs. to till final allotment**
- 3. Allotment of Seats: From 1230 Hrs. to till final allotment**

It may be noted that the admission to the Pre- PhD Course work will be based on the merit list (First the main list and then the waiting list, if required for vacant seats if any) and shall be subject to fulfilment of eligibility requirements and other details as given in the Admission Brochure and shall also be governed by the provisions of the Regulations governing the award of Ph.D. degree. This is further to remind you that the admission into the Pre-PhD programme is subject to verification of documents and understanding that you have already verified your eligibility and the declaration given by you in the admission form.

It may be noted that at the time of attending the counselling and taking admission, if candidate's name is in the main list or at the time of attending the counselling and taking chance for admission for vacant seats, if any, if candidate's name is in the waiting list, the candidates are required to bring all the testimonials, certificates, mark sheets, other certificates as required, in original for verification and one set of photocopies duly self- attested (See Annexure – I). **Selected candidates are required to deposit the admission fees of Rs.8,050=00(Rupees Eight Thousand Fifty only) through a bank draft only drawn in favour of Registrar, Guru Ghasidas Vishwavidyalaya, Bilaspur (CG) and payable at par at Bilaspur (CG) at the time of final allotment of the seat on the date of counselling.**
