3. UGC NET (LS/JRF)/SLET qualified certificate (If any).
4. Original Transfer Certificate; Migration Certificate, Character certificate.
5. Original Caste Certificate in case of OBC/SC/ST applicants along with 2 photocopies. Those belonging to reserved category must bring valid caste certificate as per Govt. of India rules. OBC applicants must bring a noncreamy-layer valid certificate from the competent authority as per government of India rules.
6. Income Certificate for OBC Candidates is must.
7. Four recent passport Size photographs
8. Gap-Certificate, (if any), in the form of affidavit in original.
9. Requisite fee (10,000/- Approx) which will be deposited through challan issued by the Department.
