### **Documents Required for Admission:**

**Note:** If any of the below mentioned documents will not be produced at the time of counselling, then in that case the candidate will lose his/her candidature for admission.

1. Original Admit Card of VET examination.
2. 4 Photocopy Sets of 10th and 12th mark sheet along with original.
3. Original Transfer Certificate.
4. Original Migration Certificate.
5. Original Caste Certificate in case of OBC/SC/ST candidates along with 2 photocopies.
6. Income Certificate for OBC candidates is must as per GOI guidelines.
7. 5 recent passport size photographs.
8. Gap Certificate, if required.
9. Physical handicapped certificate in case of physically handicapped as per GOI norms.
10. Requisite fee (**3000/- Approximate**) which will be deposited through challan issued by the Department.
11. Candidates should have their valid **email id and contact number**.
12. If the candidates having same VET Score then in that case the relative merit will be decided by their 12<sup>th</sup> class percentage (%) and 10<sup>th</sup> class % respectively. i.e. highest percent obtained by the candidate in 12<sup>th</sup> class will be given first preference in admission. In case all the candidates having same percent marks in 12<sup>th</sup> class also then 10<sup>th</sup> class marks will be taken into account for admission.
13. In case the candidates having same VET Score as well as same score in 12<sup>th</sup> class and 10<sup>th</sup> class then in that case the candidate who is older in age will be given first preference in admission.
