Dear Candidate.

With reference to above, this is to inform you that the Counseling for admission to Pre-PhD course will be held on 15th October, 2015, Thursday in the Department of Management Studies as per the programme given below:

1. Reporting and Registration: From 1000 Hrs. to 11.00 AM

2. Verification of Documents : From 1100 Hrs. to till final allotment
3. Allotment of Seats : From 12.00 Hrs. to till final allotment

It may be noted that the admission to the Pre-PhD Course work will be based on the merit list (First the main list and then the waiting list, if required for vacant seats if any) and shall be subject to fulfillment of eligibility requirements and other details as given in the Admission Brochure and shall also be governed by the provisions of the Regulations governing the award of Ph.D. degree. This is further to remind you that the admission into the Pre-PhD programme is subject to verification of documents and understanding that you have already verified your eligibility and the declaration given by you in the admission form.

It may be noted that at the time of attending the counseling and taking admission, if candidate's name is in the main list or at the time of attending the counseling and taking chance for admission for vacant seats, if any, if candidate's name is in the waiting list, the candidates are required to bring all the testimonials, certificates, mark sheets, certificates etc., in original for verification and one set of Xerox copies duly self-attested (See Annexure – I). Selected candidates are required to deposit the admission fees of Rs.8,580=00(Rupees Eight Thousand Five hundred eight only) through a bank draft only drawn in favour of Registrar, Guru Ghasidas Vishwavidyalaya, Bilaspur (CG) and payable at par at Bilaspur (CG) at the time of final allotment of the seat on the date of counseling.

Candidates must note that the OBC certificate and not belonging to creamy layer from any other person/authority and without the central Govt. format shall not be accepted in any case.
