At the beginning of the meeting the Vice Chancellor welcomed to all. After discussion with Deans, School of Studies and DSW, it was unanimously resolved as under:

1. All Heads of the Teaching Departments are authorised to give admission to the students in UG/PG first semester for the session 2015-2016, through Departmental Admission Committee upto 24<sup>th</sup> July, 2015 (the last date of transfer of application 23<sup>rd</sup> July, 2015 at 5.00 P.M.) where seat is still lying vacant, provided that the students have appeared VET-2015 and requesting for transfer, and have not taken admission in any course of the University. No fresh applications will be entertained.

2. The subjects of School of Physical Sciences and School of Mathematical & Computational Sciences be opened to students of Anthropology and Library & Information Science students under CBCS, 2015. Students having Science background in  $12^{th}$  Class will be allowed to choose papers from above two Schools. No separate class arrangement for students will be made. The students will have to choose according to available time-table.
