## NECESSARY DOCUMENTS AT THE TIME OF COUNSELLING

For Counselling, Candidates are required to bring following documents:

1. Transfer Certificate, in Original
2. Migration Certificate, in Original
3. Character Certificate, in Original (if issued separately)
4. Original Gap Certificate (in case of gap in the study)
5. Original High School (10th) Mark sheet and three Self-attested photocopies of it
6. Original Higher Secondary (12th) Mark sheet and three Self-attested photocopies of it
7. Original B.Com. (Hons) / B. Com. Mark Sheet and its three Self-attested photocopies.
8. Original and Valid Caste Certificate in case of OBC Candidate issued by competent authority and three Self-attested photocopies of it.
9. Caste Certificate of OBC **should preferably be Permanent (स्थायी)**. In case of Temporary (अस्थायी) certificate, it **should not be older than 6 months on the date of counselling.**
10. **Income Certificate is must for OBC Candidates (Not older than one year on the date of counselling)** and two Self-attested photocopies of it.
11. Eligibility Certificate from Academic Section of GGV, Bilaspur; if required
12. Three recent passport size colour photograph
13. To facilitate Central Government's initiatives to promote Cashless transactions, fee for First Semester (around Rs. 4,300/- + bank charges) is to be deposited. Candidates are advised to bring their ATM Cards/ Debit Cards/ Credit Cards/

Internet Banking details and the Mobile Phone which is registered with such facilities to deposit their fees using cashless systems.

14. Original Aadhaar Card and its two self-attested Photocopies

15. If the candidate is bank account holder, then original bank pass-book and its two self-attested photocopies

16. If the candidate is bank account holder, then original bank pass-book and its two self-attested photocopies

**Note: Candidates shall themselves be responsible in case, they don't bring and submit any or all of the above documents as required.**

### GENERAL INSTRUCTIONS

1. Invitation for Counselling does not mean a guarantee for admission.
2. Admission shall be done according to Final Merit List declared on the date of counselling after verification of documents of present and registered candidates.
3. Candidates found eligible for admission after counselling has to deposit the requisite admission fee on the same day, without which, admission shall not be considered completed.
4. Minimum Eligibility for admission into the course is at least 50% (No rounding-off) at Graduation Level (B.Com. (Hons.)/ B. Com.).
5. Maximum Age Limit for Admission in the course is (as on 01 - July - 2019) 25 Years. Age relaxation for OBC candidates will be provided as per rules.
6. No separate letter for counselling shall be issued to the candidates.
7. Three announcements in the name of eligible candidate shall be made on the date and time of counselling. If candidate does not respond to the last call, he /she shall be treated as absent and next candidate in the merit list shall be called for admission.
8. The claim for admission shall itself be cancelled for such candidates who remain absent on the date and time of counselling.
