- 7. Original Higher Secondary (12th) Mark sheet and its three Self-attested photocopies.
- **8.** Original B.Com. (Hons) / B. Com. Mark Sheet and its three Self-attested photocopies.
- 9. Original and Valid Caste Certificate in case of OBC / SC / ST and EWS Certificate for EWS Candidate issued by competent authority and three Selfattested photocopies of it.
- 10. Caste Certificate of OBC / SC / ST and EWS Certificate for EWS category should preferably be Permanent (स्थाई). In case of Temporary (अस्थाई) certificate, it should not be older than 6 months on the date of counselling.
- 11. Income Certificate is must for OBC Candidates (Not older than one year on the date of counselling) and two Self-attested photocopies of it

- **12.** Valid Original Certificate of Person with Disability (PWD) Category issued from Competent Authority with two Self-attested photocopies of it.
- 13. Eligibility Certificate from Academic Section of GGV, Bilaspur; if required
- **14.** Original Identity Proof (preferably Aadhaar Card) with two Self-attested photocopies of it.
- **15.** Fitness Certificate issued from Competent Doctor (Certificate should clearly bear the Registration Number and Mobile Number of such Doctor)
- **16.** Three recent passport size colour photograph.
- 17. To facilitate Central Government's initiatives to promote Cashless transactions, fee for First Semester (around Rs. 5,000/-) is to be deposited only through online mode. Candidates are advised to bring their ATM Card/Debit Card/ Credit Card/ UPI / Internet Banking details and the Mobile Phone which is registered to receive OTP for the same to deposit their fees using Cashless systems.

Note: Candidates shall themselves be responsible in case, they do not bring and submit any or all of the above documents as required.

GENERAL INSTRUCTIONS

- 1. Invitation for Counselling does not mean a guarantee for admission.
- 2. Admission shall be done according to Final Merit List declared on the date of counselling after verification of documents of present and registered candidates.
- **3.** Candidates found eligible for admission after counselling has to deposit the requisite admission fee on the same day, without which, admission shall not be considered completed.
- **4.** Minimum Eligibility for admission into the course is at least 50% (No rounding-off) at Graduation Level (B.Com. (Hons.)/ B. Com.). Relaxation in minimum eligibility to SC/ST candidates will be provided as per rules.

- 5. Maximum Age Limit for Admission in the course is (as on 01 July 2019) 25 Years. Age relaxation for OBC, SC and ST candidates will be provided as per rules.
- **6.** No separate letter for counselling shall be issued to the candidates.
- 7. Three announcements in the name of eligible candidate shall be made on the date and time of counselling. If candidate does not respond to the last call, he /she shall be treated as absent and next candidate in the merit list shall be called for admission.
- **8.** The claim for admission shall itself be cancelled for such candidates who remain absent on the date and time of counselling.
