
Venue: SLT Institute of Pharmaceutical Sciences, Guru Ghasidas Vishwavidyalaya, Bilaspur.

*Horizontal reservation to physically challenged (PH) candidates in each category shall be available as per Govt. of India (GOI) norms.

The Candidates have to report in person of counseling at the venue, along with the following documents in original for verification and **prescribed fee** as well as **two sets of photocopies (self-attested)** of all the documents for record, failing which candidates will not be considered for admission:

1. Mark sheet and certificate (for proof of age) of high school or equivalent examination.
2. Mark sheet and certificate of 10+2/Intermediate Examination.
3. Transfer certificate, migration certificate and character certificate from the institution last attended.
4. Gap certificate in form of affidavit (if applicable).



5. Valid caste certificate (for claiming admission under reserve category as per Gol norms).
6. Income certificate (for OBC category only; certificate should be issued within 6 months at the time of counselling in Gol format).
7. For EWS category the candidates should provide all the documents as per rule.
8. Physically challenged (PH) certificate if applicable.
9. Two passport size colour photographs.
10. Aadhar card
11. Payment should be made through ATM/debit card/credit card/online bank counter.


The fee to be deposited on the counselling date (in case student gets admission).

1. B. Pharm. (Semester fee) Rs. 16,640/-
2. D. Pharm. (Yearly fee) Rs. 26,200/-


