After the due date the admission will not be considered.

Admission will be confirmed by the department only after physical verification of documents during study/first semester of the course. Mere securing a place in merit list at the time of online provisional admission does not entitle an applicant to be considered for confirmed admission unless otherwise he/she fulfills the eligibility conditions with necessary supporting documents. If an applicant inadvertently allowed to give admission who otherwise does not fulfills the minimum eligibility requirements with supporting documents, he/she cannot, at a later date, use the permission as a right to claim that he/she meets the eligibility requirements of VET. His/Her admission will be canceled by the University without any prior notice.
