3. Higher Secondary (Class XII) Mark sheet
4. Valid Caste Certificate (SC/ST/ Recent OBC Non-Creamy Layer, and PH, and EWS certificate) as per GOI rule (if claiming admission under reserved category)
5. B.Ed./ B.A. B.Ed./B.Sc. B.Ed./B.El.Ed. Mark sheet
6. Graduation Mark sheet (final year mark sheet showing all three-year marks) reflecting marks of all subjects including compulsory/core courses like language, EVS etc.
7. Post-Graduation Mark sheet (final year mark sheet showing all two-year marks) reflecting marks of all subjects.

IMPORTANT NOTE:

1. Please strictly follow the schedule for admission process as mentioned above. Only **coloured scanned** documents, arranged in the sequence as mentioned above, (Documents Required) in **a single pdf file**, will be considered for the scrutiny process by the department.
2. **Rename** the pdf as mentioning your name and application number.
3. Only **single submission** of documents is allowed, and the **maximum size of pdf file is 5 MB**.
4. Please do not send repeated documents.
5. Merit list of candidates will be decided on the basis of highest marks of B.Ed./ B.A. B.Ed./B.Sc. B.Ed./B.El.Ed. Degree. However, in case of any tie in marks of (B.Ed./ B.A. B.Ed./B.Sc. B.Ed./B.El.Ed.), higher percentage of UG/PG Degree shall be considered for the merit. In case of tie of UG/PG Degree, higher percentage of Higher Secondary (Class XII) shall be considered for the merit, in case further tie, higher percentage of High School (Class X) shall be considered for merit. And if in case of further tie , elder students shall be considered in merit.
6. If the candidate did not submit valid (SC/ST/ Recent OBC Non-Creamy Layer, and PH & EWS) Certificate his/her candidature will be considered under Unreserved (UR) Category.
7. The category shown in the Application form will be considered as final and no change will be entertained.
8. Payment of fee will be done online through Allahabad Bank link available in GGU website i.e. www.ggu.ac.in.
9. The amount of fee for First Semester of M.Ed. Programme is 7700/- (Seven thousand seven hundred rupees only). Fee once submitted to the University will not be refunded to any candidate after starting of classes. However, refundable fee shall be refunded to the candidates according to the provisions of relevant Ordinance of the University.
10. After the scrutiny of documents, the merit list of short-listed candidates will be uploaded at university website as per the admission schedule.
