Documents Required:

1. High school (Class X) mark sheet/Date of birth Certificate.
2. B.P.ED /Integrated B.P.ED mark sheet.
3. Highest sports achievement certificate of last three years.
4. Transfer certificate.
5. Character certificate.
6. Migration certificate
7. Gap certificate (if any)
8. Aadhaar Number
9. Cast Certificate as per GOI norms (SC/ST/EWS/OBC-Non Creamy Layer with income certificate)
10. Fitness Certificate Issued by Registered Medical Practitioner.
11. A soft/ scanned copy of application form submitted online by student and receipt of the fee paid.
12. The candidates should not be more than 28 years of age for unreserved category, 31 years for OBC and 33 years for SC/ST candidates on 1st July 2020 for seeking admission in M.P. Ed. courses.
13. After the verification of original mark sheets / Sports certificates etc., if candidate fails to fulfill the eligibility criteria as per NCTE / University rules regarding age, relaxation etc, the application form / admission shall be cancelled.

Note:- Online Provisional admission will be given to the candidates after declaration of merit-list in order of merit. Admission will be confirmed by the department only after physical verification of documents during study/first semester of the course. Mere appearance and securing a place in merit list at the time of provisional admission does not entitle an applicant to be considered for confirmed admission to any discipline unless otherwise he/she fulfills the eligibility conditions with necessary supporting documents. If an applicant inadvertently allowed to give admission who otherwise does not fulfills the minimum eligibility requirements with supporting documents, he/she cannot, at a later date, use the permission as a right to claim that he/she meets the eligibility requirements of VET. His/Her admission will be canceled by the University without any prior notice.
