It is important to note that in case of tie in the merit list between the candidates at UG level the merit will be decided as per their percentage of 12th class and in case of tie at 12th class then merit will be decided as per their percentage of 10th marks, further, if there is also a tie at class 10th level, then the senior (age wise) candidate will be given chance for the admission.

The admission of an applicant listed above is purely provisional subject to fulfillment of all criterions for admission to this course

- The applicants shown in these lists are informed to ensure that they are eligible in all respect as per University Guidelines. If it is found that an applicant is not eligible, his/ her admission can be cancelled at any stage of the course due to any of the reasons including false information, Non- eligibility, etc.
- The applicant must keep ready all documents related to Educational Qualification, Valid Caste Certificate (in case of OBC Latest non-creamy layer certificate: **Annexure attached**), Transfer Certificate, Character Certificate, etc in Original to be produced before the HOD of the Department whenever conditions permit or they are asked for.
