Candidates appearing before DRC are advised to report for the interview / presentation along with all relevant original documents and two sets of attested copies.

Important instructions to candidates

1. All qualified candidates of VRET 2018-19 and candidates under VRET exempted category 2018-19 only are eligible for reporting in the CSIT department at the stipulated date, time and venue.
2. Candidates will bring with them following documents in originals and two sets of attested copies at the time of reporting.
 - a. Mark sheets of 10th, 12th, Graduation and Post graduation from recognized board / University.
 - b. NET / NET JRF / SLET qualified certificate / Teacher Fellowship holder/ GPAT/ JEST / RGNF / DST-Inspire (Applicable to VRET exempted category).
 - c. Transfer certificate, Character Certificate, Migration certificate, Gap certificate (if any).
 - d. Two passport size colour photographs.
 - e. Valid Caste certificates (if applicable) as per Government of India rules.
 - f. Valid NOC from present Employer if employed.
 - g. A hard copy of application form submitted online by the candidate along with the receipt of fee paid while applying online.
 - h. Admit card in case of VRET category.
 - i. Any other document which they wish to show.
3. At the time of reporting the candidate must satisfy all criteria of eligibility.

4. After a candidate is recommended for provisional admission, as per the university rules, he / she will deposit the required admission fee immediately through challan issued by the office of the CSIT department at the time of admission payable through any one of these modes: Debit Card / Credit Card / Online Banking only (fee structure attached). Candidate has to submit the receipt of fee paid immediately to confirm his/ her admission, failing which admission will be cancelled and the concerned candidate will be responsible for this.

5. The admission of a candidate can be cancelled due to ineligibility of the candidate / due to any other valid reason including human error in preparing list at any time even during the course.

Note: Mere reporting does not entitle a candidate for admission to Ph.D programme in Computer Science. It is subject to fulfilment of all criteria.
